2011-2012 MAIN PROPOSAL

PROJECT TITLE: Contract Management

I. PROJECT STATEMENT

These funds are to the DNR to manage appropriations to be passed through to third party recipients. This project provides oversight of reimbursement for project deliverables and meets the requirements of the Department of Administration's Grants Management procedures as well as the recommendations of the Legislative Auditor. It aids recipients with financial compliance and ensures project consistency with appropriations laws and work programs.

II. DESCRIPTION OF PROJECT ACTIVITIES

Result 1: Reimbursement and Review **Budget:** \$234,600

Assist LCCMR pass-through recipients in obtaining reimbursement for expenses incurred for LCCMR funded projects. The DNR will reimburse pass-through recipients for allowable expenses only, review expenditures against work program objectives, and audit financial records in accordance with the "Reimbursement Manual for Minnesota Environmental and Natural Resources Trust Fund Appropriations."

This proposal includes continued administration of pass-through appropriations from 2009 and 2010 as well as the new appropriations for 2011. In addition, the requested budget of \$234,600 assumes that there will be an additional carry-forward balance from the 2009 Contract Management appropriation of \$15,000 which would be available if the language is extended. This carry-forward balance would be due in part to a staff vacancy from May to October.

III. PROJECT STRATEGY

A. Project Team/Partners: DNR works closely with LCCMR staff and each pass-through recipient to ensure that they are in compliance with the state's requirements for subcontracts, purchases and reimbursement, fund integrity, conflict of interest policies, internal audit and financial controls, etc. These services are currently provided by the DNR under the existing contract management appropriation and are proposed to transition to a professional services contract in FY12.

B. Timeline Requirements: This request will fund contract administration for the biennium. This is an ongoing responsibility created by legislative appropriations to the Commissioner of DNR for grants to third parties. DNR does not provide long-term monitoring or any services once the grant has been completed and closed.

C. Long-Term Strategy and Future Funding Needs:

As the administrator of LCCMR's pass-through appropriations, DNR is responsible for ensuring pass-through recipients comply with federal and state laws and related agency policies, such as the Department of Administration's Office of Grants Management's policies and procedures for addressing conflict of interest, reimbursement, grants oversight, reporting requirements around outcomes, etc. These complex issues can no longer be accomplished by just one person and are best accomplished through professional services which better approximate the staff resources and time needed to carry out these functions.

DNR is managing 68 open LCCMR pass-through appropriations and on average, each appropriation requires 30-35 staff hours annually to administer. While DNR has not asked LCCMR to pay for the full cost of administering the pass-through appropriations prior to submitting this proposal, DNR can no longer afford to subsidize this service beyond FY11 because of the decline of General Fund availability and fund integrity issues that ultimately affect to user groups such as snowmobilers, ATV riders, hunters and anglers.

Through FY11, DNR will continue to supplement LCCMR's contract administration and administer the program as set forth in the appropriation. DNR cannot use dedicated funds (Game and Fish Fund, Parks & Trails Fund, etc.) to subsidize activity related to LCCMR pass-through management because of fund integrity.

Future Funding Needs

For the past decade the DNR has provided contract management services for pass-through appropriations for LCCMR recommended projects. In recent years the DNR received \$150,000 in 2005, \$40,000 in 2007 and \$158,000 in 2009 for pass-through contract management, which did not adequately recover all the costs for managing the program. This occurred in part because the Office of the Legislative Auditor, the Department of Administration's Grants Management Office, and the state Legislature adopted improved grants management and financial accountability standards in 2007 and 2008. These changes demand a more comprehensive approach to administering pass-through appropriations for LCCMR.

Starting in FY12, DNR proposes to establish a professional services contract for administering the LCCMR Pass-Through Grants in the amount of \$234,600 (does not include the \$15,000 of projected carry-forward from 2009) to be billed at a professional services rate of \$60/hr. It allows the service provider (DNR) to establish the cost of providing the service while ensuring that the recipient (LCCMR) is charged only for the service provided. Services not received or provided will not be billed. DNR's professional services rates are submitted for review to Minnesota Management and Budget Services and are administered as set forth in M.S. 84.025. DNR anticipates that the professional services rates will likely increase in FY12 because the rates do not (as of now) include department shared services costs into the calculation.

The professional services rate includes the cost of the grants management unit staff (also includes a portion of the supervisor's time), travel costs, supplies, Attorney General fees, agency directs, and related costs necessary to carry out the pass-through management functions. Professional services rates are based on historical cost basis detail and do not include costs such as accounts payable, payroll, internal audit, the Commissioner's Office, or contract management services.

D. Contract Administration Requirements

Transparency and fiscal accountability rules and regulations have substantially increased over the last several years, requiring additional assistance from DNR's internal audit, accounting, and contract administration staff. The following are examples of recent changes that guide DNR's administration of the LCCMR pass-through appropriations.

- 1. Sarbanes—Oxley Act of 2002 (SOX) is a United States federal law enacted on July 30, 2002, which set new or enhanced standards for all U.S. public company boards, management and public accounting firms. The act contains 11 titles, or sections, ranging from additional corporate board responsibilities to criminal penalties, and requires the Securities and Exchange Commission (SEC) to implement rulings on requirements to comply with the new law. The act also covers issues such as auditor independence, corporate governance, internal control assessment, and enhanced financial disclosure.
- 2. Minnesota Management and Budget (MMB)'s Code of Conduct policy includes requirements for agency review and certification. The objectives of this policy are to improve accountability, identify governance processes, facilitate the timely detection of significant internal control deficiencies, and ensure the reliability of financial information.
- 3. In 2009, the Internal Control & Accountability Unit was created in Minnesota Management and Budget (MMB) as a result of the passage of Minn. Stat. Section 16A.057. The primary mission of the unit is to improve internal controls throughout state government. The unit has the following statutory responsibilities:
 - Adopt statewide internal control standards and policies
 - Coordinate executive branch agency internal control training and assistance
 - Promote and coordinate the sharing of internal audit resources
 - Monitor Office of the Legislative Auditor (OLA) reports and corresponding corrective action plans; and

- Make biennial reports on the system of internal controls and internal auditing in executive branch agencies.
- 4. In 2007, the Office of Grants Management (OGM), was established in the Department of Administration by the Legislature and is a response to a January 2007 program evaluation by the Office of the Legislative Auditor regarding state grant-making. The office began operations in September 2007. The mission of the Office of Grants Management (OGM) is to standardize, streamline and improve state grant-making practices and to increase public information about state grant opportunities. One tool for accomplishing this mission is the creation of comprehensive grants management policies as outlined in Minnesota Statute 16B.97 sub. 4 (a)(1). This office has developed and implemented 13 policies related to grants management in 2008, including conflict of interest, rating criteria, publication requirements, grant agreements, etc.
