
LCCMR Process for 2015 Recommendations

In response to the 2015 Request for Proposal (RFP), due March 28, 2014, 152 proposals requesting a total of approximately \$126.3 million were received. This RFP process is for funding available beginning July 1, 2015. For that period, approximately \$44 million from the Environment and Natural Resources Trust Fund is expected to be available to recommend for project funding. The LCCMR reviewed, evaluated, and ranked all proposals received. On June 4, the LCCMR selected 76 proposals requesting a total of approximately \$74.9 million to invite in for a presentation before the Commission for further consideration. Proposal presentations are scheduled for June 17, 18, 19, 25, and 26.

% of Total \$ Requests Selected to Present by Funding Priority Topic Areas






