- Subd. 2. **Exceptions.** Money from the trust fund may not be spent for:
- 2.4 (1) purposes of environmental compensation and liability under chapter 115B and response actions under chapter 115C;
- (2) purposes of municipal water pollution control <u>in municipalities with a population of</u>
  5,000 or more under the authority of chapters 115 and 116;
- 2.8 (3) costs associated with the decommissioning of nuclear power plants;
- 2.9 (4) hazardous waste disposal facilities;
- 2.10 (5) solid waste disposal facilities; or
- 2.11 (6) projects or purposes inconsistent with the strategic plan.
- Sec. .... Minnesota Statutes 2016, section 116P.12, subdivision 1, is amended to read:
- Subdivision 1. **Loans authorized.** (a) If the principal of the trust fund equals or exceeds \$200,000,000, the commission may vote to set aside up to five percent of the principal of the trust fund for water system improvement loans. The purpose of water system improvement loans is to offer below market rate interest loans to local units of government for the purposes of water system improvements.
  - (b) The interest on a loan shall be calculated on the declining balance at a rate four percentage points below that is the greater of one percent or 50 percent of the secondary market yield of one-year United States Treasury bills calculated according to section 549.09, subdivision 1, paragraph (c).
  - (c) An eligible project must prove that existing federal or state loans or grants have not been adequate.
- 2.24 (d) Payments on the principal and interest of loans under this section must be credited to the trust fund.
- (e) Repayment of loans made under this section must be completed within 20 years.
- 2.27 (f) The Minnesota Public Facilities Authority must report to the commission each year on the loan program any loans made to the authority under this section."

Dear Commission Member,

At the end of this past session, Governor Dayton signed into law Chapter 94, SF 1456, the Jobs and Energy Omnibus Budget Bill. The bill made significant reforms to Xcel Energy's Renewable Development Fund (RDF).

Xcel's RDF dates back to 1994, and among its original purposes was "to stimulate research and development" of clean energy technologies.

Over the years, the RDF has drifted away from its original purpose and been used by some to fund projects well removed from the 1994 mandate. Our 2017 reforms will return the RDF to its original purpose.

As such, the RDF is again available as a resource to fund basic and applied research on clean energy topics.

I have long believed that the types of clean energy and climate-related projects funded under your "Category E" by the Trust Fund simply do not match well the purposes of the of the Environment and Natural Resources Trust Fund.

I understand that the current list of 2018 recommendations includes in Category E five projects listed for a total of \$2,550,000. A number of these projects have been previously considered and not adopted by the Legislature. I suggest that you repurpose these dollars to more urgent priorities.

I believe that these projects are a better fit with the reformed RDF. To that end, I ask that all energy and climate change project applicants to the 2018 round of LCCMR funding, instead apply for RDF funds.

If any such items are included in the LCCMR funding bill, I will oppose those items and will actively seek their removal from the bill.
