David Hartwell called the meeting to order at 8:45 p.m.

Susan Thornton briefly explained today's agenda and explained the new meeting books.

 - Overview and discussion of the recommendations in the final plan (SCPP team members - Dr. Deborah Swackhamer, U of M; Dr. Anne Kapuscinski, U of M; Dr. Gerald Neimi, U of M; Dr. David Mulla, U of M; Dr. George Host, U of M; Dr. Steve Polasky, U of M; Dr. Les Everett, U of M; Jean Coleman, President CR Planning; and John Shardlow, Vice President Bonestroo Resources)

M.L. 2006, Chapter 243, Sec. 20, Subd. 10 titled "Statewide Conservation and Preservation Plan".

Dr. Deb Swackhamer presented the Statewide Conservation and Preservation Plan (SCPP). See Attachment #1 for a copy of the presentation. Dr. Swackhamer explained that the Cost Benefit Analysis component will be completed later this summer. Susan Thornton explained that the plan recommendations were not available to the Cost Benefit Team and that it was agreed to with staff that this report would come at a later date to enable the analysis.

Dr. Swackhamer explained that all staff time with the University of Minnesota was donated as inkind for any work completed on the Statewide Conservation and Preservation Plan.

Gerald Neimi (U of M, NRRI) and Anne Kapuscinski (U of M) presented the Land and Aquatic Habitat recommendations.

Sen. Satveer Chaudhary asked if the Statewide Conservation and Preservation Plan reviewed the State Comprehensive Outdoor Recreation Plan (SCORP) and agreed with the SCORP plan. Dr. Kapuscinski said they asked the Outdoor Recreation Team (SCORP) to review the SCPP Land and Aquatic Habitat Team Recommendations and incorporate the SCORP findings as appropriate. Susan Thornton reminded members that the SCORP had been presented at the last LCCMR meeting on June 11, 2008.

- Land Use Practice Final Recommendations Statewide Conservation and Preservation Plan
 - Overview and discussion of Land Use Practice final recommendations (Team members: John Shardlow, Vice President Bonestroo Resources; Dr. Les Everett, U of M)

John Shardlow (Bonestroo) and Les Everett (U of M) presented the Land Use Practice recommendations. David Hartwell asked about buffers and the regulations regarding buffers being ignored. Dr. Les Everett explained that this report does not go into that level of detail.

Sen. Jim Vickerman asked about cleaning up Lake Pepin. Dr. David Mulla stated 85-90% of the sediment in Lake Pepin comes from the Minnesota River.

Sen. Dennis Frederickson asked about peak flows and if any of the assessments have been done previously. Dr. Mulla explained in agricultural areas it has been more difficult to get a handle on and there are two issues: peak flows and volume controls. Dr. Mulla responded this issue has a lot to do with the climate changes.

Jim Barton presented the Land Use Transportation recommendations.

Jean Coleman presented the Land Use Forest recommendations.

Rep. Jean Wagenius asked if solar power was compared to other renewable energy sources. Dr. Swackhamer said that solar power is not included in the Cost Benefit Anaylsis.
