Susan Thornton requested that if after her meeting with USGS, MPCA and DNR she determines they need an extension of time for their appropriations that they be added to Subd. 16 Carryforward.

- AMEND: Commissioner Herman moved to change the following in the Appropriation Language for 2010 by adding the word "perpetual" before the wording "conservation easements" on line 176 for LCCMR ID: 097-C "Conserving Sensitive and Priority Shorelands in Cass County".
- MOTION: Commissioner Frederickson restated his motion of adoption of the Appropriation Language for 2010 and to change line 140 by replacing the "a" with "an authorized" for LCCMR ID: 101-C "Minnesota's Habitat Conservation Partnership Supplemental". Commissioner Frederickson accepted Commissioner Herman's amendment to add the word "perpetual" on line 176. The staff is to add two carryforwards to extend their appropriation to June 30, 2011: (1) M.L. 2009, Chp. 143, Sec. 2, Subd. 5, paragraph (b) Vulnerability of Fish Populations in Lakes and (2) M.L. 2009, Chp. 143, Sec. 2, Subd. 6, paragraph (b) Emergency Delivery System Development for Disinfecting Ballast Water. The staff is to make any grammatical and stylistic changes as needed and to be sent to the Office of the Revisor of Statutes motion prevailed. (Yes 13 / No 2)
