Commissioner Vickerman stated he has a cabin on Lake LaSalle so will not be voting on LCCMR ID: 112-D, "LaSalle Lake: Protecting Critical Mississippi River Headwaters Lands".

Commissioner Gibson announced she is on the board of the Belwin Conservancy. Great River Greening, a partner in the Metro Conservation Corridors (LCCMR ID: 104-D) proposes to conduct restoration activities at Belwin using the Trust Fund.

3. Process Discussion

Members discussed how there should be consideration in the allocations process on July 13 and 14 of the following; enforcement and long-term management of purchased lands, dollars to manage and enforce easements, baseline property reporting, understanding the dollars needed for restoration of acquired lands, and dollars needed for PILT.
