1. Approve agenda for LCCMR meeting for July 11, 2012

Co-Chair Hackbarth called the meeting to order at 9:15 a.m.

MOTION: Commissioner Gibson moved to approve the agenda for LCCMR meeting for July 11, 2012 – motion prevailed.

2. Approve the minutes for June 27, 2012 and June 28, 2012

MOTION: Commissioner Shimanski moved to approve the minutes for June 27, 2012 and June 28, 2012 – motion prevailed.

3. Members report potential conflicts of interest regarding today's business

Commissioner Broberg reiterated that he had previously declared a conflict of interest and sent a letter to LCCMR members listing the proposals that he has a conflict of interest with: ENRTF ID: 017-B "Controlling Terrestrial Invasive Plants with Grazing Animals", Hiawatha Valley Resource Conservation & Development, Inc.

Commissioner Herman stated that he had previously declared a conflict of interest with parts of ENRTF ID: 64-D, "Metropolitan Conservation Corridor Partnership Phase VII" entity MN Valley Trust and ENRTF ID: 105-F, "Youth Outdoors: Mississippi River Education and Employment Opportunities", Wilderness Inquiry.

Commissioner Dziedzic called members attention to a letter in the meeting packet from Senate Counsel regarding a family member working at the DNR affirming it did not constitute a conflict of interest with MN DNR's proposals submitted.

4. Discussion of proposed "DNR's Direct Support Services" for DNR proposals received for FY14 (DNR Commissioner Tom Landwehr)

DNR Commissioner Tom Landwehr and Denise Anderson presented an overview of the "DNR's proposed "Direct Support Services" expenditures and requesting that the LCCMR give consideration for funding. Commissioner Landwehr stated that he was there to speak to the LCCMR about DNR's proposed "Direct and Necessary Expenses" that they included on the DNR proposals submitted this year. There are items that the DNR believes should be allowed as expenditures that are listed as ineligible in the LCCMR RFP. The general fund support of these support services has been in decline.

Commissioner Landwehr distributed a handout titled "Draft 7/10/2012 – Revised Budget Proposals for DNR's LCCMR Proposals – Direct and Necessary Expenses (Preliminary)" and "Minnesota Biological Survey Direct and Necessary Example – Talking Points".

Example – County Biological Survey. Program has 16 positions and in those positions each position requires human resources services that includes hiring, job descriptions, payroll, performance management, training, unemployment, worker's comp, layoff and recall processing; certain financial expenses including contract services, procurement services, accounts payable, budget preparation, financial reporting; IT needs including GIS support, technical support, computers themselves, network services, email.

DNR stated they have done a detailed analysis of the expenses associated and calculated the costs. The initial proposal percentage proposed was a "placeholder" and they can now provide the actual expenses anticipated from 0% to 8.4% depending on the specific elements of each project. They are open to consideration of alternatives and are available to answer any detailed questions about the numbers.

Commissioner Gibson asked about these costs as being proposed to be charged to the ENRTF as supplanting. DNR responded that they did not believe so.

Members discussed that they would like to receive detailed information as to what makes up the shared services proposed for each proposal being recommended. LCCMR would then apply the criteria that is in the RFP regarding eligible expenses and ineligible in their consideration and vetting. They would review the ineligible expense list for future funding proposals but at this time those are the adopted rules that all of the proposers have applied under and it should not be changed at this time.

Co-Chair Hackbarth asked the Commissioner if a detailed list of the calculated expenses they included for each proposal could be provided. Commissioner Landwehr responded that they would provide the information. It was agreed that the DNR and LCCMR staff would work together on the material requested of DNR. The material would include specific list of items for each proposal and the specific calculations and include expenses calculated.

In addition, Commissioner Skoe reiterated that the LCCMR would be looking at the next meeting at the individual work plans submitted and line item budgets to see if the proposed budget items fit the criteria adopted by the LCCMR. They would not be changing expenses allowed during this funding cycle but would listen to DNR and other agencies discussion of administrative expenses for future RFPs.

Commissioner Gibson asked Co-Chair Landwehr about the "DNR Contract Management". In the discussion of the assigned contract fiscal management, Commissioner Landwehr responded that they are looking at ways to minimize the documentation requested and would be open to continuing the discussion. Members discussed that they would be looking at agency options for contract management.

Susan Thornton explained that members can set aside a certain amount of money for contract management now but discussions will continue more at the LCCMR meeting in November.

Co-Chair Hackbarth thanked Commissioner Landwehr for coming to the LCCMR today.

Commissioner Gibson asked Co-Chair Hackbarth about putting together a subcommittee to work on the issue of ""Direct Support Services"" allowed in future RFP funding.

Environment and Natural Resources Trust Fund dollars available for FY14-15 (Susan Thornton, LCCMR)

Susan Thornton explained that the Environment and Natural Resources Trust Fund is held by the State Board of Investment (SBI) and the amount available for the biennium (FY14-15) is equivalent to 5.5% of the value of the Trust Fund on June 30, 2012. Ms. Thornton explained that the preliminary amount as of June 30, 2012 is \$33,800,000 for each fiscal year. Commissioner Berner asked if any monies from year two of the biennium could be allocated this year. In response to members questions, Ms. Thornton explained that the year two money (FY15) can be recommended as an allocation.

6. LCCMR Administrative budget for FY14-15 (Susan Thornton, LCCMR)

Susan Thornton explained that the budget for FY14-15 is the same as the current biennium (FY12-13) at \$946,000 as adopted by the 2011 Legislature.

MOTION: Commissioner Berner moved to recommend \$1,000,000 for the LCCMR Administrative Budget – motion prevailed.

MOTION: Commissioner Berner moved to add LCCMR Administrative Budget at \$1,000,000 for the first year onto the allocation sheet – motion prevailed.
