A. Select proposals received in response to the 2016 Request for Proposal (RFP) for the Environment and Natural Resources Trust Fund for further consideration and presentations to the LCCMR on Sept. 29-30 and October 1, 6, 7, and 8 (as needed)

Mike Banker handed out a graph showing a compilation of member scores ranked by how many members voted for each project. Staff reviewed the summary packet of proposals received.

Members moved back to Agenda Item #4.

 Overview of New Buffer Law Provisions and Appropriation – M.L. 2015, First Special Session, Chp. 4, Art. 4, Sec. 79 [103F.48] "Riparian Protection and Water Quality Practices" – Sarah Strommen, DNR and John Jaschke, BWSR

John Jaschke, BWSR and Sarah Strommen, DNR gave a presentation on the New Buffer Law M.L. 2015, First Special Session, Chp. 4, Art. 4, Sec. 79 [103F.48] "Riparian Protection and Water Qaulity Practices" and the funding provided in the 2015 Legislative Session.

Commissioner Torkelson asked about mapping. Sarah Strommen responded that the maps are in process.

Commissioner Tomassoni asked if the \$4,000,000 from LSOHC is for buffers. John Jaschke explained that it is used to make a wildlife focused program combined with the Clean Water Fund for multiple benefits.

Commissioner Gibson asked about the proposals received for the 2016 ENRTF RFP and if any of them are funded under the new buffer law appropriations. Sarah Strommen said the law was adopted after the proposals were due to the LCCMR. Ms. Strommen explained that the proposals received have aspects that are beneficial and should be coordinated with BWSR.

Commissioner Dahms asked about county maps and asked if DNR is duplicating county maps. Sarah Strommen said that the DNR will not be redoing the drainage maps created by counties already.

Commissioner Dahms asked about private ditches. He has concerns that counties are being told by DNR that the private ditches are going to be included in the buffers. Commissioner Dahms explained that the bill specifically excludes private ditches. Ms. Strommen explained that there are some private ditches that are within the benefited area of local ditches and the idea is to buffer private ditches that are in the benefited area.

Members requested BWSR and DNR provide a formal review of ENRTF 2016 Proposals related to the new Buffer Law and appropriations; and the BWSR directive to SWCDs on Clean Water Fund funding.

Members recessed for five minutes.

Susan Thornton explained the dollars were reallocated for additional management plans and easement acquisition.

B. M.L. 2015, Chp. 76, Sec. 2, Subd. 09e, "Metro Conservation Corridors Phase VIII - Coordination and Mapping and Conservation Easements", Kris Larson, Minnesota Land Trust (MLT), \$515,000 – Work plan review and discussion of protection of water quality and quantity for easements

Kris Larson, MLT and Wayne Ostlie, MLT gave an overview of M.L. 2015, Chp. 76, Sec. 2, Subd. 09e "Metro Conservation Corridors Phase VIII – Coordination and Mapping and Conservation Easements".

In response to inquiries about the required provision to address water quality in law, Kris Larson discussed that the conservation easement document references a separate management plan for the property covered by the conservation easement to address water quality issues but the specific language is not in the legal conservation easement document. Members discussed that the actual conservation easement document should have overarching language that addresses the water quality and quantity issues and other requirements so that terms are enforceable. The conservation easement language should specifically state water quality and quantity protections that are required to be in the separate natural resources management plan so that the management plan cannot be altered at a later date to remove the protections. Members also commented that the conservation easement template had no language on maintaining native vegetation or preventing invasive species and that it should be added to the conservation easement document. The members discussed the need for the State to have a role in the enforcement of the easement provisions and amendments funded with state dollars.

MOTION: Commissioner Harper-Lore moved to approve M.L. 2015, Chp. 76, Sec. 2, Subd. 09e "Metro Conservation Corridors Phase VIII – Coordination and Mapping and Conservation Easements" contingent on LCCMR staff working with Minnesota Land Trust (MLT) on resolution of previous appropriations expenditures – motion prevailed.

Commissioner Torkelson asked staff to review briefly ENRTF ID: 186-H ""Roseau Lake Watershed: Targeted Water Quality Improvement". Susan Thornton explained in the Environment Finance Bill (M.L. 2015, First Special Session, Chp. 4, Art. 4, Sec. 140, Water Retention Projects) language was added that instructed the agencies to submit proposals to Clean Water Fund, Outdoor Heritage Fund (LSOHC), and the Environment and Natural Resources Trust Fund (ENRTF) related to water storage retention; the fund proposal deadlines were also waived until August 1, 2015. Ms. Thornton reminded members they received this proposal by email along with the proposal submitted to the LSOHC (LSOHC Proposal ID: NEW titled "Roseau Lake Rehabilitation") which was for \$9 million for water storage and a shallow lake restoration on Roseau Lake. Ms. Thornton explained the agencies worked together and the proposal received was their submission to the ENRTF.

M.L. 2015, First Special Session, Chp. 4, Art. 4, Sec. 140, Water Retention Projects

By August 1, 2015, the commissioner of natural resources, in cooperation with the commissioners of agriculture and the Pollution Control Agency, the Board of Water and Soil Resources, and other interested parties, shall develop proposals for significant large-scale projects that provide flood water retention, water quality improvements, nutrient and sediment reduction, and wildlife habitat for submission to the Lessard-Sams Outdoor Heritage Council, Clean Water Council, and the Legislative-Citizen Commission on Minnesota Resources for funding in

fiscal year 2017. Any deadlines established by the Lessard-Sams Outdoor Heritage Council, Clean Water Council, or the Legislative-Citizen Commission on Minnesota Resources are waived for purposes of the submissions.

Members requested information on the process used to respond to this directive and what else was considered.

Commissioner Torkelson asked for a review of the proposal ENRTF ID: 186-H "Roseau Lake Watershed: Targeted Water Quality Improvement". Susan Thornton gave an overview of this proposal and the proposal submitted to LSOHC.
