Appropriation Language:

04(h) Acquisition of Lands as Scientific and Natural Areas \$227,000 the first year and \$228,000 the second year are from the trust fund to the commissioner of natural resources to acquire land with natural features of statewide significance in the scientific and natural area program long-range plan and to improve land acquired with this appropriation. Land acquired with this appropriation must be sufficiently improved to meet at least minimum management standards as determined by the commissioner of natural resources. Funding provided to acquire Scientific and Natural Areas (SNA) this biennium was used to acquire critical lands with plant communities such as native prairie and rare species habitat. A total of thirty (30) landowners were contacted concerning land protection. Of these, eight (8) agreed to have an appraisal conducted with these funds, of which 7 were completed in this time frame. Completed appraisals resulted in approximately 179 acres of land being acquired as SNAs with the LCMR funds. These lands were acquired at Prairie Coteau SNA in Pipestone County (92 acres), Sedan Brook SNA in Stearns County (40 acres), Cottonwood River Prairie SNA in Brown County (approximately 2 acres), and Pine Bend Bluffs SNA in Dakota County (45 of 118 acres with funds provided to SNA).

At least four other appraisals are underway as a result of landowner contacts made during this LCMR project. One of the parcels appraised during this period will be acquired with new LCMR funds in the metro area this biennium. In addition, due to contacts made during this LCMR acquisition project, another two (2) landowners have since agreed to have appraisals conducted.

In summary, funds provided through the LCMR have been successfully used to protect critical tracts of land as State Scientific and Natural Areas for native plant communities and rare plant and animal species. In addition, contacts made with landowners during this period are resulting in new land appraisals that in turn will result in the protection of additional parcels of land with rare and unique natural resources, in the future.

Result 1: Contact private landowners, initiate appraisals and acquire lands at anywhere from one to four sites.

Result Status: 6/14/03 – 6/30/03: The work program amendment of June 17, 2003 was approved to add Clay County to the list of sites where acquisition was proposed. This permitted the SNA Program to initiate the appraisals of the gravel resources at a key site in Clay County. However, in that the appraisal was just initiated, the costs for the appraisal will not be taken from this account. Also during this period approximately 2 acres was optioned at the Cottonwood River Prairie in Brown County.

1/1/03 – 6/13/03: A work program amendment (June 17, 2003) is requested to add Clay County to the list of sites where acquisition is proposed (see attached list). This will permit the SNA Program to initiate and complete appraisals of the gravel resources at a key site in Clay County. Since the inception of the SNA work program, the Felton Prairie Stewardship Plan, funded by LCMR has been completed. One of the key focal points of the Felton Prairie Stewardship Plan is the protection of the native prairie resources found at the site. In order to start the protection process, envisioned by the LCMR funded Stewardship Plan, the value of the gravel resources at the site must be assessed. Shifting existing funds in this work program will permit the completion of appraisals. Establishment of values will permit protection partners to initiate negotiations with the County. It is anticipated that these appraisals will cost over \$40,000 due to the amount of work and analysis required to develop economic values for this extensive resource. The area to be appraised contains in the neighborhood of 22 million cubic yards of high quality gravel on over 500 acres of high quality native prairie.

Also during this period a 17 acre parcel was appraised at Pine Bend Bluffs and discussions are being held with the landowner. Another parcel has been submitted for appraisal at Pine Bend Bluffs. 7/1/02-12/31/02: 92 acres containing wet and mesic prairie was acquired at the Prairie Coteau SNA for \$47,000. 118 acres of forest at the Pine Bend Bluff SNA was acquired through the LCMR appropriation to the SNA Program (\$292,00) and from funding provided by Metro Greenways (\$ 477,500). Pine Bend Bluffs is the number 1 priority and Prairie Coteau the number 9 priority listed on Attachment A. 7/1/01-2/14/02: 40 acres containing mesic prairie was acquired at the SNA to date with \$29,000 of LCMR funds. This is the number 2 priority listed on Attachment A.

Result 2: Conduct informational meetings as necessary with local units of government.
