Overall Project Outcome and Results

The project is a small craft harbor on Lake Superior in cooperation with the DNR, US Army Corps of Engineers, and local governments. Other sources of funding totaling \$7,350,000 include state bonding, county state aid road funds, and federal Corps of Engineers' funds. An agreement was signed between the Corps of Engineers and the DNR on March 10, 2004 for construction of the project. Under the agreement, the DNR was required to transfer state funds to the Corps and the transfer took place in late spring 2004. The Corps then bid the project in the summer of 2004 and is responsible for completion of construction which started in October. The protected harbor at McQuade Road will provide boat access and shelter from storms for a wide range of boating activities (primarily fishing). The facility includes a 3.1 acre harbor basin created by modified berm-like breakwaters, boat launch ramps, docks at the ramps, and 60 car/trailer and 23 car only parking areas. The project includes lighting, walkways, landscaping, and shore fishing structures. A bridge is being constructed on County Road 61 to allow boaters to access the launch ramps underneath. Future plans include restrooms and a fish cleaning station. The project is the result of a fourteen-year extensive planning process incorporating stakeholder and local communities' interests. Partners include the City of Duluth, Lakewood and Duluth Townships, and St. Louis County—all parties to a Joint Powers Agreement. Construction will be completed by fall 2006.

When completed, the project is intended to serve all citizens by providing both shoreline and boat access. The safe harbor will provide a park-like setting, and in addition to boating and shore fishing, citizens will be able to experience the lake from shore or by accessing the breakwater on an accessible route.

C. Project Partners

Members of the Joint Powers Board are the City of Duluth, St. Louis County, Duluth, and Lakewood Townships. Other partners are the U.S. Army Corps of Engineers, McQuade Public Access Committee (representing local stakeholders and user groups). The Committee has conducted a planning process for over fourteen years to select a publicly acceptable and technically feasible site, conduct a public process, provide public information, assist with coordination, and assist the DNR and the Corps with the design and parameters of the facility.

St. Louis County is assisting with the road/bridge designs for County Road 61 and McQuade Road.

D. Time

The LCMR funds were liquidated by June 30, 2004. Because of the Corps of Engineers requirements, there have been delays in the project. By federal law the Corps must bid and construct the project. The construction time estimate is two years with completion by fall 2006.

VII. DISSEMINATION

The public will be updated with project progress through the McQuade Public Access Committee and the DNR as necessary. Once completed the project will be in DNR maps and the website.

VIII. LOCATION

The project is located on McQuade Road and Scenic Highway 61 adjacent to Lake Superior. Governmental jurisdictions include the City of Duluth, Lakewood and Duluth Townships and St. Louis County. The project is approximately half way between the Duluth Harbor Entry and Knife River.
