Overall Project Outcome and Results

The objective of this program is to foster public/private and intergovernmental partnerships by providing state matching grants to private organizations and local governments for "on the ground" fish, wildlife and native plant habitat improvement projects and related research and for avariety of environmental service and conservation projects.

A total of 39 grants totaling \$406,513 were provided to private and non-profit organizations, educational institutions, local governments and soil and water conservation districts. Of that total, 24 Conservation Partners grants were made for "on the ground" fish, wildlife and native plant habitat improvement projects and research or surveys of fish and wildlife directly related to specific habitat improvement. The remaining 15 Environmental Partnerships grants were made for a variety of community environmental service, education, information, and conservation projects.

A number of habitat restorations were completed, including lakeshore, river shore land, wetland, prairie and oak savannah restorations. A number of tree and native grass planting projects were also funded, including a customized tree planting machine. Among the Environmental Partnerships projects funded were rainwater gardens, stream sampling, interpretive exhibits and signs, a Bluebird Trail, a bog walk project, a field study program for grade school students, a Lake Superior Coastal Reforestation Booklet, a natural resource inventory and management plan, and a land stewardship conference.

Since these projects are located throughout the state, many Minnesotans will benefit directly by having access to the project areas. Minnesotans in general will also benefit from information or research that may be applicable in many locations, such as the sago pondweed research or the coastal forest reforestation booklet, or from the habitat improvements that benefit fish and

wildlife populations and help protect water quality. Environmental education, interpretation and information projects also help foster an appreciation for the need to conserve our natural resources, particularly for younger generations.

\$256,000 the first year and \$256,000 the second year are from the trust fund to the commissioner of natural resources for matching grants of up to \$20,000 to local government and private organizations for enhancement, research and education associated with natural habitat and environmental service projects. This appropriation is available until June 30, 2006, at which time the project must be completed and final products delivered, unless an earlier date is specified in the work program.

II. and III. FINAL PROJECT SUMMARY:

IV. OUTLINE OF PROJECT RESULTS: These programs provide financial assistance and incentives to private organizations and local governments for projects that result in improved habitat, environmental education activities, and a variety of community environmental service projects.

Result 1 Conservation Partners Matching Grant Program

Description: \$276,465 of the appropriation was spent for this program, including \$246,465 for grants and \$30,000 for personnel costs. The matching grants funded 24 projects for private organization or local government efforts to provide "on the ground" fish, wildlife and native plant habitat improvement projects and research or surveys of fish and wildlife directly related to specific habitat improvement through cooperation by private organizations and local governments. This differs somewhat from the original estimate of \$250,000 for 26 projects because of the individual nature of each proposal and the relative rankings. An attempt was made to come as close as feasible to the original estimates. The maximum grant amount is \$20,000. \$30,000 was used for personnel costs, which include staff time to process grant agreements and payments and additional administration support for project solicitation; application evaluation and ranking; review and approval of project billings; project liaison with grant recipients; oversight and monitoring; closeout and reporting; etc.

Result 2 Environmental Partnerships Matching Grant Program

Description: \$190,048 of the appropriation was spent for this program, including \$160,048 for grants and \$30,000 for personnel costs. The matching grants funded 15 projects for private organization or local government efforts to complete a variety of community environmental service, education, information and conservation projects. This differs from the original estimate of \$202,000 for 29 projects because of the individual nature of each proposal and the relative rankings. An attempt was made to come as close as feasible to the original estimates. The maximum grant amount is \$20,000. Eligible projects include, but are not limited to: community environmental service projects to clean up natural areas, such as streams, lakes and wetlands; preparation and production of environmental education products such as handbooks, manuals, videos and newsletters; and development of educational materials and exhibits that demonstrate environmental conservation principles. \$30,000 was used for personnel costs. The types of personnel costs are the same as described in Result 1.

VI. PAST, PRESENT AND CURRENT SPENDING:

- A. PAST SPENDING: The grants program was first funded with LCMR funds in 1995. The total funding appropriated for the program since then is \$2,510,000. The Environmental Partnerships Matching Grant Program was first funded with LCMR funds in 1997. The total appropriated for the program since then is \$700,000. The total appropriated for both programs in 2001 was \$900,000. These totals have been matched by at least an equal amount of local government and private organization funds.
- **B. Current Spending for the Project Period:** A total of \$466,513 has been spent, leaving a balance of \$45,487.
- **C.** Required Match: Grant recipients must provide a 50/50 match, resulting in a match of at least \$406,513.
- D. Future Spending: N/A

VII. PROJECT PARTNERS:

- **A. Partners Receiving LCMR Funds:** DNR staff are responsible for soliciting, evaluating and ranking applications; developing grant agreements; reviewing and approving reimbursement requests; project liaison; review and monitoring of results; processing payments; and project closeout. Projects are implemented by local governments and private organizations.
- **VIII. DISSEMINATION:** Grant application information is distributed on an annual basis through mailings to eligible local governments and organizations. Information about the grant programs is also available on DNR's web page and through the DNR's Financial Assistance Directory.
- **IX. LOCATION:** The grant program is a statewide program. Projects were located at various locations throughout the state.
- X. REPORTING REQUIREMENTS: Periodic work program progress reports will be submitted not later than October 2003, October 2004, and October 2005. A final work program report and associated products will be submitted by June 30, 2006.
