### **Overall Project Outcome and Results**

The purpose of this project was to acquire inholdings from willing sellers within state park and recreation area boundaries. Approximately 931 acres in the following locations were completed using the 2005 LCMR appropriation:

Crow Wing State Park 213 acres (also used LCMR 2003 funding)

G. Crosby Manitou State Park 420 acres (also used CZM Grant)

Whitewater State Park

Judge C.R. Magney State Park

80 acres

This appropriation was significant in that it continued the progress toward acquiring critical private inholdings within statutory state park boundaries. The Crow Wing State park acquisition protected additional lands along the Mississippi River wildlife corridor in an area that is experiencing rapid residential development. These parcels will also preserve the natural views from the park facilities and helped facilitate the connection of the Paul Bunyan State Trail. The George Crosby Manitou and Judge C.R. Magney State Park parcels were acquired to protect lands within the Lake Superior watershed and offer recreational opportunities such as hiking (one mile of hiking trail included), backpacking and birdwatching. The Whitewater State Park parcel protects the integrity of the valley and park by preserving the bluff above the park.

## **Project Results Use and Dissemination**

Parcels acquired have been shown on updated state park boundary maps, and have been described in the Minnesota State Park Traveler newspaper and other publications.

Land acquired with this appropriation must be sufficiently improved to meet at least minimum management standards as determined by the commissioner of natural resources. This appropriation is available until June 30, 2008, at which time the project must be completed and final products delivered, unless an earlier date is specified in the work program.

### II. and III. Final Project Summary

The purpose of this project was to acquire inholdings from willing sellers within state park and recreation area boundaries. Approximately 931 acres in the following locations were completed using the 2005 LCMR appropriation:

Crow Wing State Park 213 acres (also used LCMR 2003 & 2005 Bonding funding)

G. Crosby Manitou State Park 420 acres (also used CZM Grant funding)

Whitewater State Park

Judge C.R. Magney State Park

80 acres

This appropriation is significant in that it continues the progress toward reducing the backlog of acquiring private in-holdings within statutory state park boundaries. These private in-holdings currently total about 48,000 acres.

#### **IV. Outline of Project Results:**

Ownership of approximately 213 acres within the statutory boundary of <u>Crow Wing State Park</u>: the Division of Parks and Recreation acquired this parcels with the help of the Conservation Fund. This organization was able to appraise, negotiate and close on the purchase in a timely manner. *The DNR utilized LCMR 2003 funds (\$100,000) to help acquire this parcel and \$6,000 in 2005 Bonding funds to pay for administrative costs.* Acquiring the 213 acres protected the Mississippi River corridor and the natural views from the park facilities and helped facilitate the connection of the Paul Bunyan State Trail.

Ownership of approximately 420 acres within George Crosby Manitou State Park: CZM (Coastal Zone Management) grant money (\$100,000) was utilized as a match to acquire acreage within George Crosby Manitou State Park. LCMR 2005 funds provided the match for this acquisition. This acquisition consolidated lands into a contiguous unit containing hiking trails, backpacking campsites and protect ecologically significant resources and scenic vistas in the park.

Ownership of approximately 218 acres within Whitewater State Park: This parcel protects the integrity of the valley and park by preserving the bluff above the park.

Ownership of approximately 80 acres within <u>Judge C.R. This acquisition preserved one of the remaining undeveloped parcels along the Brule River watershed. This acquisition will also allow expansion of existing hiking trails to a major waterfall.
