Three local NWTF Chapters located the sites, ordered the seedlings, and planted them. These seedlings are native to MN and were purchased from Lee's Nursery in Fertile, MN, Polk County. Lee's nursery was chosen because it provided quality native plants for habitat restoration and because it consistently provides good quality plant stock and cooperation.
