Work Program Summary

Overall Project Outcome and Results

LCMR funds were used for acquisition and professional services fees necessary to acquire conservation easements. Easements acquired are held by DNR Forestry on private forestland in the Mississippi Headwaters (2) corridor. Lands are permanently protected from development and help assure wildlife habitat preservation and water quality. This appropriation, along with \$500,000 in other state funds and more than \$800,000 in other non-state leveraged funds, helped to protect 1660 acres of mature hardwood forest.

Project Results Use and Dissemination

Minnesota DNR Forestry has used funds to purchase a conservation easement for the Sugar Hills Project which closed on May 11, 2007 and for professional services associated with that project. \$441, 900 in non HCP ETF funds were used to complete this project. Other funds were not secured as projects were completed with state funds and private funds that leveraged state funds other than the ENTF.
