Sound bite of Project Outcomes and Results

Keeping forests alive and surrounding our communities is vital for water protection, provide safe drinking water to residents, and benefit wildlife populations into the future. Landowners within the Camp Ripley Sentinel Landscape completed 76 forest stewardship plans totaling 13,104 acres and 38 water quality practices in their woodlands.

Overall Project Outcome and Results

Forests provide vital functions including water protection, providing critical habitat for wildlife, and contributing resources which communities rely on. The conversion of land within the Camp Ripley Sentinel landscape is happening at an alarming rate. Upland forest lands within LSP have declined by 28 percent (200,000 acres). These riparian forest areas are threatened by rapid urban and rural residential development within the City of Baxter, Crow Wing, Cass, Morrison, and Todd Counties (MN 2010 Census Data). This project aimed to work with private residents and certified forest plan writers to engage landowners into completing a forest stewardship plan and implement a best Management Practice on their woodlands. These plans provide important information about their forest resources and make it easier to enroll into forest protection programs like the Sustainable Forest Incentive Act or 2c. Parcels were targeted based on modeling, MPCA watershed Restoration and Protection Plan goals, and the county water plan. Landowners were reached through mailings or talking with their local foresters or certified plan writers in the region. In total, 76 forest stewardship plans (13,104 Acres) were written by SWCD technicians or certified forest plan writers. All landowners were then enrolled into some form of forest protection program like a conservation easement, SFIA, or 2c. In addition, 38 water quality projects were implemented on those properties to benefit drinking water as well as improve wildlife habitat and forest resiliency. Minnesotans will directly benefit from this work because 1.7 million people draw their drinking water from the Mississippi River. Forests are natural filters which traps pollutants and treat stormwater before it enters a water body.

Project Results Use and Dissemination

Mailers and in-person meetings were the two main modes of communication with landowners in the LCCMR boundary. The SWCD produced countless materials that were sent to prioritized landowners about forest plans and water quality BMP's. The best success with outreach came from in-person meetings with landowners and certified forest stewardship plan writers. The plan writers already had a great working relationship with the community and could disseminate materials quickly and have those 1 on 1 conversations. The Crow Wing SWCD

is developing a story map to present the successes to landowners and constituents. It will be an interactive map with resources for landowners.

I. PROJECT TITLE: Forest Management for Mississippi River Drinking Water Protection

II. PROJECT STATEMENT:

In order to maintain source water protection, habitat, and riparian forests, the Crow Wing Soil and Water Conservation District (SWCD) plans to partner across watersheds boundaries (Crow Wing, Long Prairie, Mississippi Brainerd, Platte River) with The Nature Conservancy, MN DNR, Board of Water and Soil Resources (BWSR) Todd, Morrison, Wadena, and Cass SWCD's to implement 25 best management practices (BMPs) and 50 private forest management plans. This project is based off the most recent Camp Ripley Landscape Stewardship Plan (LSP) which is a forest management and water quality plan for 719,463 acres of area; roughly a 10-mile radius around Camp Ripley which is located north central Minnesota. This unique hydrologic confluence contains 45,000 acres of lakes and streams, 30,825 acres of permanently protected land (BWSR- RIM Easements and MNDNR Fee Acquisition), 40 miles of the Mississippi River, 52,000 acres of State Game Refuge, 13 MN DNR Wildlife Management Areas, County, and City Land. According to the US Forest Service, the Mississippi River - Brainerd and Crow Wing River Major Watersheds are ranked number 5 and 6 respectively out of 81 Minnesota major watersheds for the importance of private forests to provide clean water downstream (Forest, Water and People 2009). Upland forest lands within LSP have declined by 28 percent (200,000 acres). These riparian forest areas are threatened by rapid urban and rural residential development within the City of Baxter, Crow Wing, Cass, Morrison, Wadena, and Todd Counties (MN 2010 Census Data).

For that reason, a protection strategy is needed to connect public and private forest lands. To create that protection strategy, we will copy the efforts from the Clean Water Legacy-Tullibee Lakes Watersheds Forest Stewardship Project. The project area will focus on Little Elk, Long Prairie, Crow Wing, Mississippi Brainerd, Gull and Nokasippi rivers' sub-watersheds (MN DNR Hydrological Unit Codes 12) to implement private forest management plans on working lands to enroll into Sustainable Forest Incentive Act (SFIA) or 2c tax programs and complete BMPs on private and public land. Prior to implementation, the CWC SWCD will hire an environmental consultant to analyze existing data sets, run water quality models, identify where the greatest habitat and water quality values overlap within targeted minor watersheds, and provide parcel list of targeted landowners. The CWC SWCD will lead and coordinate this project with, the environmental consultant, SWCDs, private forest plan writers, and private and public land owners. The CWC SWCD will follow MN DNR requirements for forest management plans and the buffer initiative, and follow BWSR State Cost-Share Policies for BMPs which includes contracts, site inspection, plans, cost estimates, and SWCD Board approval. This project will build upon existing partnerships such as the Camp Ripley Army Compatible Use Buffer (ACUB) program and MN Forest Resource Council -North Central Landscape Committee. This project will leverage additional Clean Water Fund support through MNDNR Forestry and BWSR and other local private resources.

The ENRTF supported pilot project proposal is to work with private landowners and provide them guidance on the best management towards a water protection approach for their forest thru a forest stewardship plan. The project will reimburse landowners for their forest stewardship plan upon signing up for:

- Sustainable Forest Incentive Act (SFIA) allows annual payments from the MN DOR to enrolled owners of forested land as an incentive to practice long-term sustainable forest management. (8-year minimum enrollment, 4 years to end agreement),
- A conservation easement thru The Army Compatible Use Buffer Program a protection/development reduction strategy that ensures Camp Ripley's continued ability to operate and train soldiers year around by reducing encroachment to the Camp. The MN Board of Water and Soil Resources conveys easements through the local SWCDs which restricts further development and allows the landowners to continue current land use and protect forestry units. Funding sources are the Department of Defense, National Guard Bureau and Lessard-Sams Outdoor Heritage Council. (perpetual agreement) or
- Agree to perform a targeted riparian forest conservation project (minimum 10-year life span) The landowner may also enroll into 2c Managed Forest Land Classification. Property owners that own forested land and who actively abide by the prescriptions set forth in a qualifying forest management plan may receive a reduced class rate of 0.65 percent on any eligible land.


Signing up for one of these three options will guarantee a long-term contract commitment for forest protection. The targeted riparian forest restoration projects must follow the Board of Water and Soil Resources native vegetation establishment and enhancement guidelines. Forestry Conservation Practices created by the NRCS and listed in the NRCS Field Office Technical Guide (FOTG) will be implemented as the BMP guidelines.

III. OVERALL PROJECT STATUS UPDATES:

Project Status as of January 31, 2017: On Tuesday, August 23, 2016, the Crow Wing SWCD hosted a partner meeting to update all partners about the project. Over 11 people attended the meeting, including partners from DNR, BWSR, Camp Ripley, The Nature Conservancy, Todd, Morrison, and Crow Wing Counties. We also completed the request for proposal to three contractors. The Crow Wing SWCD Board met on December 21, 2016 and authorized the contract to Brinks Wetland Services LLC. The SWCD and Brinks Wetland Services LLC an executed agreement for the GIS Services. Additionally, the Crow Wing SWCD worked with MN DNR, MN Forest Resource Council, and US Forest Service to develop a work plan to leverage \$ 50,000 US Forest Services to assist with forest education, landscape stewardship plan, and forest management within same targeted area.

Amendment request is for the following items:

- 1. To add Wadena County to work area for the Activities 1, 2, and 3. Crow Wing HUC 12 (070101061104) includes 25 parcels within Wadena County.
- 2. At the time of the application we were not aware that Wadena County was included within the Subwatershed.



3. Budget Amendment: To add additional staff time for Activity 1 to District Technician, from District Manager. At the time of the work plan completion the District Manager had additional time available to assist with this project. Additional work load and grants have been added to the District Managers workload. We are requesting to move \$10,000 from the District Manager to District Technician. 

We hired a District Technician in April 2018. He has taken over this program and projects.

Amendment Request 12/13/2018

The purpose of this request is to extend the deadline in which funding is provided. Current funding is supposed to end on June 30th, 2019, we are requesting this be changed to June 30th, 2020. Given the extra year, this will allow landowners one more season to do projects. With a transition in staff and a time lapse in-between, promotion of the grant and projects were put on hold for several months. With current outreach and staff, stewardship plans and best management practices (BMP's) have been coming in steadily. With current projections, we will exceed the number of stewardship plans and potentially exceed our number of BMP goals for this grant if allotted the additional year. A year is requested instead of six months because most timber stand improvement projects occur in the winter months to reduce erosion. With most logging operations, it is too late for new customers to get work accomplished during the 2018/2019 season and would need to wait until next winter to complete these practices. Many timber related activities also require a follow-up planting which would happen in the spring, hence the June 30 of 2020. In order to receive the extension (if approved by LCCMR legislature), we understand the following benchmarks must be met: (Amendment Approved by LCCMR 5/22/19)

Amendment Request 08/26/2019

In this amendment request we are looking to transfer funds from the activity 3 (BMP) budget to the activity 2 (Stewardship Plan) budget.

- Activity 3 would be decreased by \$20,000 to a revised budget of \$155,000.
- Activity 2 would be increased by \$20,000 for a revised budget of \$95,000.

Due to a heavy amount of landowners enrolling into easements or covenants, we have a majority who do not have to do a BMP through us (SWCD) as a result of their stewardship plan. This leaves us with more project money than we have projects, and more potential stewardship plans than we have funds available for activity 2. Since having a stewardship plan is the first step in management, I think it is a valuable investment. (Amendment Approved by LCCMR 9/30/2019)

Project Status as of January 31, 2020

To date, we have completed 66 of the 50 required forest stewardship plans for 10,452.45 acres and 27 of the minimum 25 BMPS for 348.25 acres. Stewardship acres achieved in this report and the next will be dwindling as plan writing money has almost ran out.

The Crow Wing SWCD has completed the following since the last update:

- 13 completed forest stewardship plans for 1,604.25 acres.
- 6 stewardship plans in the works for 927 acres.
- 8 completed BMP's for 138.75 acres.

To date, we have completed 75 forest stewardship plans of our 50 required for a total of 11,726.45 acres within the sentinel landscape. We have also completed or initiated active management with 38 landowners. 29 of those have been cost-shared through this grant of the required 25 for a total of 391.55 acres of cost-shared projects. Minimal work was done for the next year of this grant as it was expected to conclude after this update.

The Crow Wing SWCD has completed the following since the last update:

- 9 completed forest stewardship plans for 1,274 acres.
- 9 completed BMP's for 66.3 acres.

Amendment Request October 14, 2020:

In this amendment request we are looking to move \$9,000.00 from Activity 3 sub part

Professional/Technical/Service Contracts to Activity 3 Personnel District Technician. This is because prior to the knowledge of an extension, all existing projects were finalized, and no projects were in the hopper. Technician time was almost gone and active projects were coming to completion. After the Covid extension was granted, there were no active projects in the hopper and almost no technician time available to continue the work. The funding transfer is needed to pay for technician time to find, set up, and oversee new projects to try to draw down the project money remaining. Without more technician time, there would be no more money to set up new incoming projects. Amendment Approved by LCCMR 10/26/2020.

Project Status as of January 31, 2021:

To date, we have completed 76 Forest Stewardship plans of the required 50 for a total of 13,104.75 acres. We currently have 30 completed cost-share contracts with 3 more actively doing management for a total of 400.5 acres. We will not have a lot more acreage for either, if any after this report due to dwindling funds and recruitment efforts since this grant is in the final stages.

Final forest stewardship plans and best management practices were completed and paid out before the June 30th deadline. Total plans and BMP's consist of 76 completed forest stewardship plans for 13,104.75 acres and implemented 63 projects with 38 landowners.

Overall Project Outcomes and Results:

The Crow Wing SWCD worked with private landowners to complete 63 practice types with 38 different landowners. It lead to the active management of 397.55 acres of land for water quality and wildlife projects. All lands had a forest stewardship plan completed before BMP's were implemented.

Status as of July 31, 2018

Status as of January 31, 2019

Since the last report, outreach methods have been altered and it has proven effective. Almost doubling our number of applicants during this last update period. If current trends continue, we will have no problem reaching our 50-stewardship plan goal and 25 bmp goal by the June 2020 deadline, pending amendment approval. Allowing us more time to complete as many projects as possible with the funding that remains.

Since the last update, many of the BMP's were completed due to the original deadline of 2019. With the 2020 extension we already have 10 BMP's that will need to be completed by next summer and more will follow. Hitting the goals of 25 BMP's and 50 Stewardship plans is now easily within reach and we can focus on utilizing BMP money before the new deadline.

Status as of January 31, 2020

Since the last update, we have exceeded the required amount of stewardship plans by over 20. Several large dollar management practices have been completed with more to come. We are slated to meet our BMP goal as well by the grant deadline. Stewardship Plans will be decreasing with the next update as funds are dwindling for those, so the focus will be primarily on using the activity 3 money before June.

Status as of July 31, 2020:

Since the last update we have completed a large number of BMP's with most of the contracts being completed. We also were able to spend the majority of the plan writing funds and have very few dollars left. With the year extension given to us for Covid-19, we are hoping to spend the rest of the activity 3 money on new projects and utilize the rest of activity 1 by coordinating with partners over the coming year.

Status as of January 31, 2021:

Being in the final stages of this grant, incoming projects have been slim. Several landowners did another year's worth of projects since they had more time to do so. By the time these projects wrap up there should be very few dollars remaining in all activities. One large forest stewardship plan was completed but not yet paid for, hence no change in the dollar amount for activity two. We are hoping the grant will be pretty much drained by the final update.

Final Report Summary: August 15, 2020

The Crow Wing SWCD and consultants spent \$297,211.40 out of the \$300,000 awarded in the grant. There was still \$2669.77 remaining for Personnel and \$118.83 for Professional/Technical/Service Contracts. All projects, plans, and time have been completed to date.

VII. PROJECT STRATEGY:

A. Project Partners:

-Crow Wing SWCD - MN Forest Resource Council

-Morrison SWCD - MN DNR Forestry

-Cass SWCD - Board of Water and Soil Resources -Camp Ripley -Natural Resource Conservation Service

-The Nature Conservancy --Mississippi Headwaters Board

-Todd SWCD _Wadena SWCD

This technical team will assist with parcel prioritization process. The team plans to capitalize on existing partner landowner solicitation networks that will promote this new program, plus offer it as an additional private land owner benefit/opportunity within this targeted project area.

B. Project Impact and Long-term Strategy:

The initial project impact would affect Todd, Morrison, Cass, Wadena, and Crow Wing Counties within the LSP project area working collaboratively to locally deliver private forest management plans that enable enrollment in NRCS forestry conservation practices, the SFIA program, or conservation easements. This minor watershed parcel prioritization methodology implements local county water plan goals that also roll up as implementation of MPCA Watershed Restoration and Protection Plan goals, for the Crow Wing River section of this project area. This new delivery system will inform and lead strategies, yet to be developed in the BWSR One Water One Plan process soon to come to these major watersheds. Long-term, this ENRTF supported pilot project would lead to a program that builds in other funding sources for sustainability. Those sources would likely include: Outdoor Heritage funds in conjunction with protection focused partners (MHB, Camp Ripley), Clean Water Funds, NRCS program, US Forest Service programs and potential federal collaborative funding though the Sentinel Landscapes program.

In summary, this pilot project targets not only the water quality and quantity resource values, but also the habitat corridors called out as a priority in the LSP and local county water plans. This project will stack public and private benefits, allow for working lands and sustainable local economy, will be administered and delivered by local government via the SWCD's, and can be ramped up to greater scale for statewide source water protection. The Mississippi Headwaters is the source water for 1.7 million river water dependent citizens today, with a growing demographic of dependence on that resource in the future.

C. Funding History:

The Crow Wing SWCD will follow the example of the Clean Water Fund, Forest Stewardship Project – Tullibee Lake Watershed program. In the last 2 years, the Crow Wing SWCD has funded over 50 plans that have enrolled in either SFIA or 2c. The program has installed 6 forestry BMP's with 4 more in the works for this spring. The

Tullibee Lakes Forest Stewardship Project has also assisted in the commitment of several conservation easements that are currently being completed.

VIII. FEE TITLE ACQUISITION/CONSERVATION EASEMENT/RESTORATION REQUIREMENTS:

Restoration

1. Provide a statement confirming that all restoration activities completed with these funds will occur on land permanently protected by a conservation easement or public ownership.

The Crow Wing SWCD will work with partners to complete restoration actives on Reinvest in Minnesota BWSR held easements or other public lands. Within the Camp Ripley ACUB area there are 30,000 acres of conservation easements and over 52,000 acres of public land.

Forest enhancements practices will be completed on all lands that agree to the minimum 10 year operation and maintenance agreement.

2. Summarize the components and expected outcomes of restoration and management plans for the parcels to be restored by your organization, how these plans are kept on file by your organization, and overall strategies for long-term plan implementation.

In the last 5 years, the Crow Wing SWCD has become a local leader and expert in technical assistance to landowners on restoration and BMPs. Since 2010, the SWCD has completed 200 enhancement projects from native plantings, rain gardens, stormwater, tree planting, and forest improvements. The SWCD has great process for project implementation and long term plan for implementation. This includes: pre-site visits, project plans, good relationship with private contractors, and technical experience with project management skills, landowner databases, and ability to work with landowners to complete the project. For this specific grant, the SWCD will wait for the water quality modeling to start landowner outreach for BMPs and restoration activities. The SWCD will coordinate with partners and ACUB team to identify specific parcels and BMPs. The Crow Wing SWCD will than partner with corresponding county to implement the restoration and BMP activities.

3. Describe how restoration efforts will utilize and follow the Board of Soil and Water Resources "Native Vegetation Establishment and Enhancement Guidelines" in order to ensure ecological integrity and pollinator enhancement.

In addition, the SWCD will require that all trees and plants come from MN DNR approved native plant nurseries. We also require that contractors or landowners follow BWSR Native Vegetation Establishment and Enhancement Guidelines and utilize all native seed mixes. All projects will follow the US Department of Agriculture Natural Resource Conservation Service Practice Field Guide.

4. Describe how the long-term maintenance and management needs of the parcel being restored with these funds will be met and financed into the future.

To guarantee long-term assurance of public benefit, the SWCD will complete inspections on projects and require a maintenance plan. The SWCD will utilize the BWSR State Cost-Share Contract and process for all restoration activities.

This includes:

- 1) All restoration and improvement projects will have an operation and maintenance plan with landowner for the effective life of the project as per the State of MN; Cost Share Program Manual (Part VI).
- 2) The Cost-Share Contract will be between the SWCD Board and landowner/land occupier.
- 3) SWCD will provide periodic maintenance inspections on the 1, 3, and 9 year after completion (BWSR Guidance document Operations and Maintenance and Inspection of Practices).
- 4) Landowner will be required to have a 50 percent match towards the project.

As a part of the maintenance agreement the SWCD will perform on-site inspection(s) during the first year to ensure projects are functioning properly. The SWCD staff will also instruct participants on correct maintenance procedures which will include mulching, weeding, sediment removal, checking outflows, invasive species, and replanting plants. After the second year, the project participant will be required to maintain the site annually. Additionally, the SWCD will follow up with participants during years three and nine to ensure projects remain functional and provide technical assistance if needed. All maintenance requirements will be included in the contract and explicitly described to participants. Lastly, the Crow Wing SWCD works directly with the Conservation Corps of Minnesota (CCMI) to help with maintenance on larger projects. In order to finance maintenance into the future the SWCD will:

- 1) Receive grants from the CCMI to have the crews help with maintenance on SWCD projects.
- 2) Build 2-3 years maintenance cost into the contract for project with a contractor.
- 3) Require landowner to maintain the project into the future.

5. Describe how consideration will be given to contracting with Conservation Corps of Minnesota for any restoration activities.

The Crow Wing SWCD works closely with the CCMI for project installation and maintenance of restoration projects. We work with landowners to obtain a signed agreement with the CCMI crew to help with restoration activities that will be included in the cost-share agreement for re-imbursement to landowner. The Crow Wing SWCD also works with Apprentice Program and Clean Water Grant funds to hire crews and apprentice to help with maintenance and project inspections. Since 2011, the SWCD has had 5 seasonal CCMI Apprentices, hired over 25 days of Crews, and received over 50 days of Crews in grants.

6. Provide a statement indicating that evaluations will be completed on parcels where activities were implemented both 1) initially after activity completion and 2) three years later as a follow-up. Evaluations should analyze improvements to the parcel and whether goals have been met, identify any problems with the implementation, and identify any findings that can be used to improve implementation of future restoration efforts at the site or elsewhere.

The SWCD will complete project evaluations on all restoration activities and follow BWSR inspection schedule which requires inspection year 1, 3, and 9. An evaluation report will be filed with the project folder. If project improvements are needed the SWCD will work with the landowner to complete improvements.
