Appropriation Language: For the cost of improvements and betterments of a capital nature and acquisition by the Council and local government units of regional recreational open-space lands in accordance with the Council's policy plan as provided in Minnesota Statutes, section 473.147. This appropriation must not be used to purchase easements.

I. PROJECT STATEMENT:

The Metropolitan Council (Council) serves as the fiscal agent for the 10 Regional Parks Implementing Agencies (Agencies): the Counties of Anoka, Carver, Dakota, Ramsey, Scott and Washington; the Cities of Bloomington and Saint Paul; the Minneapolis Park and Recreation Board; and Three Rivers Park District, who own and operate their respective units of the Regional Parks System. <u>M.S. Sec. 473.315</u> authorizes the Council to award grants for recreation open space purposes to the ten Agencies.

The activities were approved in 2017 by the Agencies' elected boards or will receive final approval within the coming months. The activities were then presented to state legislators during the 2018 legislative session as a request for General Obligation bond funding for the metropolitan Regional Parks System. The Council matches General Obligation bonds at the rate of \$2 in regional bonds for every \$3 in state bonds. Funds are allocated to the 10 Agencies according to a formula set in the *2040 Regional Parks Policy Plan*, as authorized by

<u>M.S. Sec. 473.147</u>. At its meeting on August 22, 2018 the Council is expected to take action on providing the same rate of match for the appropriation set in <u>M.L. 2018, Art. 6, Chp. 214, Sec. 4, Subd. 9</u>. If approved, this match will be applied to the appropriation as a whole. The Council is seeking workplan approval from LCCMR for the \$10 million in ENTRF bonds; details on the spending of regional bond matching dollars are purely informational.

This project implements the named master plans throughout the metropolitan Regional Parks and Trails System through a variety of capital projects:

- Two activities will remodel or rehabilitate existing facilities;
- Three activities are reconstruct or rehabilitate park or trail pavement;
- Two activities will replace play areas;
- Two activities will implement transportation improvements; and
- Three activities will develop new outdoor recreation facilities.

The budget presented includes the ENRTF bonding and the Council's match, which is <u>shown in Other Funds</u>. The budget for individual activities has been split between ENRTF and Council bonds to ensure maximum efficiency in grant administration. <u>Nine activities will be funded entirely from Council bonds</u>, eleven will be funded entirely from ENRTF, and <u>one activity is funded with a mix</u> of Council bonds and ENRTF. Projects funded entirely from Council bonds will be managed internally at the Council.

SCOTT COUNTY – LAKEFRONT DEVELOPMENT AT SPRING LAKE REGIONAL PARK

Design and engineering consultant services for design through construction phase for the development of a nine-acre lakefront area within Spring Lake Regional Park, including trails, fishing and picnicking facilities, passive open space, play area, lakeshore restoration, four-season pavilion, and support infrastructure (parking lot, entrance road, restroom). The design process will include a public planning process to assess how the master plan concept meets current regional recreation needs that can be served by this site, including opportunities to address populations that are under-served by the Regional Parks System in Scott County. The recommended design will include facilities reflective of this assessment. The lakefront project area is guided as the most intensely developed area of the park, with human interaction and access to the riparian zone a priority. This will be done in an environmentally sensitive manner, with a goal to preserve as much of the natural vegetation as possible, to include measures to protect lake water quality from site-related development, and measures to support shoreline stabilization. The design will incorporate treatments to support water quality, such as buffers and porous pavement, and it will limit the development footprint through such measures as limiting lake access to specific points. The Metropolitan Council approved the master plan for Spring Lake Regional Park on December 18, 2006; the business item in support of the master plan is not online but is available upon request.

VI. PROJECT PARTNERS:

A. Partners outside of project manager's organization receiving ENRTF funding

Regional Parks Implementing Agencies, including Anoka and Scott Counties; the Cities of Bloomington and Saint Paul; Minneapolis Park and Recreation Board; and Three Rivers Park District.

B. Partners outside of your organization NOT receiving ENRTF funding

Projects from four Regional Parks Implementing Agencies, including the Counties of Carver, Dakota, Ramsey and Washington were presented to the 2018 Legislature as part of the General Obligation bonding request for the metropolitan Regional Parks System. The Metropolitan Council's \$2-to\$3 match was applied to the appropriation as a whole, and for the sake of simplicity all of the projects proposed by these four counties will be funded entirely with Council bonds. Additionally, one project for Three Rivers Park District will be funded partially with ENRTF and partially with Council bonds, to tie out the allocation amounts exactly.

For activities 11 and 12, the Capitol Regional Watershed District will partner on water quality improvements above and beyond standards normally provided for similar projects. They will provide financial support for this work to be identified in the future.

VII. LONG-TERM- IMPLEMENTATION AND FUNDING:

Operation and maintenance costs are eligible for partial reimbursement through state appropriations in accordance with <u>Minnesota Statutes</u>, section 473.351. Specific long-term implications are found below.




