Sound bite of Project Outcomes and Results

Acquisition of Minnesota State Park and State Trail land provides permanent, effective and consolidated protection and management of pristine natural areas representative of diverse landscapes throughout the entire state of Minnesota for perpetual enjoyment by State Park and Trail users.

Overall Project Outcome and Results

Minnesota Environment and Natural Resources Trust Fund funding resulted in the Department of Natural Resources acquiring approximately 377 acres of land within the statutory boundaries of four Minnesota State Parks and three legislatively authorized State Trail

- Acquired 0.58 acres of land within the Casey Jones State Trail corridor. This parcel provides access and parking to the trail.
- Acquired 158.84 acres of land within Frontenac State Park. This parcel also has a stunning overlook and incredible birding opportunities for unique trail hiking experiences.
- Acquired 18.19 acres of land within the Great River Ridge State Trail corridor. This parcel will allow for growth of the trail 1.5 miles enable a future connection to the town of Eyota.
- Acquired 134.7 acres within Maplewood State Park. This property will preserve high quality hardwood forest-covered hills that blend into a series of scenic rolling agricultural fields, meadows, and wetlands.
- Acquired 59.97 acres within William O'Brien State Park. The parcel will be restored to a historical native prairie setting. This area is under consideration for the new gateway bike trail extension route.
- Acquired 5.4 acres along the Minnesota Valley State Trail corridor. The division of Parks and Trails can now freely act on maintenance concerns that occur on the section that the department owns. The bluff portion contains a relatively diverse terrace forest.

- Acquired 61.04 acres within the Goodhue Pioneer State Trail corridor. This acquisition allows for the trail to be extended an additional 2.75 miles and utilize an existing bridge. Natural resources include a small portion of Hay Creek and a dry bedrock bluff prairie.
- Acquired 68.53 acres within Myre-Big Island State Park. The property will be restored, and it is anticipated that hiking trails will be built for park visitors to utilize and enjoy.

Project Results Use and Dissemination

All acquisitions dissemination have been communicated through updated state park maps reflecting state managed land and are identified as public land open to be used and enjoyed by all visitors.

Appropriation Language:

\$2,000,000 the first year is from the trust fund to the commissioner of natural resources to acquire high-priority in-holdings from willing sellers within the legislatively authorized boundaries of state parks and trails to protect Minnesota's natural heritage, enhance outdoor recreational opportunities, and improve the efficiency of public land management. Priorities include but are not limited to Minneopa, St. Croix, Frontenac, and Crow Wing State Parks. A list of proposed acquisitions is required in the work plan.

I. PROJECT STATEMENT:

Acquire Minnesota's 75 State Parks and State Recreation Areas and 26 State Trails top priority in-holdings within legislatively established boundaries of from willing sellers.

This proposal is an investment in the future and fulfills State Legislature direction to acquire parcels from willing sellers within legislatively defined State Parks, Recreation Areas and Trails systems. This project will protect and enhance Minnesota's environment, promote positive economic impacts, and increase outdoor recreation opportunities for all Minnesota citizens.

Each State Park, State Recreation Area and State Trail has a master plan. These plans include public, county and local jurisdiction input and define desirable land to be acquired within legislatively defined boundaries and alignments. These parcels represent unique landscapes and natural resources to be managed for the benefit of the public statewide. In addition to preserving and protecting Minnesota's natural resources and cultural heritage, these projects also generate positive local economic impacts created by enhanced recreation and tourism opportunities.

Most Minnesota State Parks and Trails projects are once-in-a-lifetime opportunities. Interested sellers often have a vision to include their family's treasured property in the State Park and State Trail system so that it can be enjoyed by the public in perpetuity. If funding doesn't exist to pursue an acquisition, the property may be subdivided, developed or taken off the market for decades.

The Minnesota Department of Natural Resources (DNR) has identified and ranked each parcel within legislatively defined boundaries and alignments for State Parks and Trails. DNR maintains a general statewide priority list that is reviewed and updated annually. Potential projects are analyzed using investment criteria established in the DNR Parks and Trails System Plan. If a requested acquisition is not successful, an LCCMR workplan amendment to include the next priority State Park, State Recreation Area and State Trail acquisition may be requested.

II. OVERALL PROJECT STATUS UPDATES:

First Update March 1, 2020 One of the four acquisition projects have been appraised. The landowner reviewed and signed the option. As for the other three projects, they are in early phases of acquiring the parcels.

Second Update September 1, 2020 Frontenac acquisition closed 7/1/2020. As for the other three projects, they are in early phases of acquiring the parcels due to loss of acquisition consultant.

Amendment Request December 16, 2020 Jennifer Christie has left the Department of Natural Resources and Shelby Kok is filling her old role. Amendment Approved by LCCMR 2/5/2021

Third Update March 1, 2021 Minneopa, St. Croix, and Crow Wing State Park parcels are no longer viable at this time because the seller is no longer interested in selling at this time. New parcels have been identified at Casey Jones State Trail, Charles A. Lindbergh State Park and Great River Ridge State Trail.

Amendment Request April 9, 2021: Seeking an amendment on the following activities.

Activity 1: Seeking an amendment to replace Minneopa State Park 30 acres with a 1-acre trail head on the Casey Jones State Trail. It is expected this amended activity will not use all the allotted activity budget. Will be looking for an additional acquisition to use unutilized funds.

Activity 2: Seeking an amendment to replace St. Croix 64 acres with a 12-acre parcel at Charles A. Lindberg State Park. The anticipated budget will be about the same. The land value increase is due to the structures on site and is located along Pike Creek.

Activity 4: Seeking an amendment to replace Crow Wing Stat Park 3 acres with a 18 acre parcel along the legislatively authorized Great River Ridge State Trail. It is expected this amended activity will not use all of the allotted activity budget.

With the amended activities, it is not expected that the allotted funds will all be utilized. A 5th Activity will be identified and requested come September 1 update. **Amendment Approved by LCCMR 5/20/2021**

Fourth Update September 1, 2021: Activities 1, 3 & 4 are in the development of property information packets to be dispersed to the appraisal unit within Lands and Minerals. Estimated timeline of making an offer is late winter to all landowners.

Amendment Request September 20, 2021: Seeking an amendment to add an activity to consume the nonutilized funds. The 5th Activity addition request is 134 acres within Maplewood State Park. Reduce Activity 3 to reflect accurate costs and to fund the requested Activity 5. These adjustments will not influence the overall appropriated amount.

Amendment Approved by LCCMR 10/25/2021

Fifth Update March 1, 2022: All uncompleted activities have completed appraisals and are on schedule to close on or prior to June 30, 2022.

Amendment Request April 21, 2022: Seeking an amendment to add two activities to consume the non-utilized funds. The 6th Activity addition request is a split fund on 60 acres within William O'Brien State Park. The 7th Activity addition request is 5 acers along the legislatively authorized Minnesota Valley State Trail. Take the unused funds from Activity 1 and apply to Activities 6 & 7. These additions will not influence the overall appropriated amount.

Sixth Update March 1, 2023: All activities but two have successfully been acquired. The two that have yet to be acquired will be so by fiscal year end. Both of those activities are in the status of preparing/reviewing closing documents. Many of the projects came in under budget. Those remaining activity budges will be assigned to Activity 6 William O'Brien. Activity 6 is split funded between two different LCCMR appropriations ML19 and ML20.

Amendment Request April 7, 2023: Seeking an amendment to increase the budget for professional services amount to accommodate the increase. Those funds would be removed from the anticipated fee title costs. No increase to the overall project is requested.

Amendment Request May 19, 2023: Seeking an amendment to take activities from LCCMR ML 21 approved list to consume the soon to be expiring funding, removing an activity that is no longer utilizing LCCMR funding, request extension for Activity 6, and adjust negative balance in the professional services expenditures in the budget report.

- Two activities would be removed from LCCMR 21 grant added to this grant to help consume expiring funding, Goodhue Pioneer State Trail, 60-acres and Jay Cooke State Park, 40-acres (Activities 8 & 9). All associated project costs within the fiscal year 2023 will be expenditure corrected to come out of this grant's appropriation.
- One activity from LCCMR ML21 would be split funded to help consume expiring funds, Activity 10.
- Activity 2 is no longer utilizing LCCMR funding. Replacement activities have been identified above.
- Activity 6 has funds encumbered and a signed option. A utility easement has been identified on the property and there are issues with getting the language cleaned up.

• Increase the amount allotted to professional services costs in the budget report to remove the negative balance. This adjustment will not affect the overall appropriation.

Eighth Update March , 2024: All activities have been completed. Currently working on the properties to get them visitor/user ready.

Seeking Amendment Request: It was discovered that funds were approved to be used towards purchasing a publicly owned property, Jay Cook State Park formerly owned by Carlton County. It is proposed to return the expended funds back to LCCMR. There are no projects that can be supplemented to utilize these funds due to the funding was extended to finish a project, that was successful. Once the amendment is approved funds will be sent back.

Jay Cooke State Park Activity was and amended project to the project list. The property owner was clearly stated however in the Landowner Type Column in the List document a typo occurred and listed it under privately owned when it should have stated publicly owned. This error caused an oversight by the reviewer and the submitter for the request. The amendment was approved and should not have been without the LCCMR committees' approval. Since the project has completed there was no opportunity to go back to the committee to seek approval. It was determined that the best course of action was to return the funds spent. To prevent this action to take place in the future these steps have been put in place. Project manager will review LCCM requirements, project manager with review all data entered to ensure accuracy before submitting for approval, provide the LCCMR reviewer additional context on the property by listing property owner's last name.

ACTIVITY 1 Title: Casey Jones State Trail, Murray County, 1 acre Description:

Acquire approximately 1 acre of land located in the legislatively authorized boundary of Casey Jones State Trail. The parcel is an important step in furthering the development of the Casey Jones State Trail. The state has nearly completed a joint powers agreement with Murray County that would allow the county to mow and maintain a hiking trail starting at this trailhead and extending up to two miles to the West. In future years, the management goals for the trail involve connecting this segment to the nearby community of Woodstock. This parcel will provide parking and access to the trail.

ACTIVITY 2 Title: Charles A. Lindbergh State Park, Morrison County, 12 acers Description:

This parcel has Pike Creek running through, which is a tributary to the Mississippi River. This property is ideal for trail expansion, additional canoe campsites and a visual buffer to surrounding development.

Purchasing this parcel will allow for growth of the trail 1.5 miles enable a future connection to the town of Eyota. Trail uses approved by the master plan include bicycling, hiking, inline skating, snowmobiling, and horseback riding.

ACTIVITY 5 Title: Maplewood State Park, Otter Tail County, 134 acres Description:

Acquire a 134 acre property within the statutory boundary of Maplewood State Park. This property will preserve high quality hardwood forest-covered hills that blend into a series of scenic rolling agricultural fields, meadows, and wetlands. Fritz Lake is partially included within this parcel along with numerous ponds and wetlands supporting a wide variety of wildlife habitat (nesting trumpeter swans, eagles and sandhill cranes).

ACTIVITY 6 Title: William O' Brien State Park , Washington County, 60 acres Description:

Acquire a 60-acre property within the statutory boundary of Maplewood State Park. The project would be split funded with M.L. 2018, Chp. 214, Art. 4, Sec. 02, Subd. 09k, "Minnesota State Parks and State Trails". This parcel would close the western side of the park boundary. The parcel would be restored to a historical native prairie setting extending the naturalist communities of this region. This area is under consideration for the new gateway bike trail extension route. This parcel would help protect higher quality resources in other areas by redirecting the trail to this added parcel.

ACTIVITY 6 ENRTF BUDGET: \$220,000

1. Acquire 60 acres of land within the statutory boundary of William O'Brien State Park	June 30, 2022

First Update March 1, 2020:

Second Update September 1, 2020: Initial conversations with the landowner. Received divisional approval to proceed with purchase. Original agreement was for 20 acres

Third Update March 1, 2021: Landowner became discouraged with how long of a process it was working with the DNR. Parks and Trails Council of Minnesota (PTCM) was asked to step in to help acquire this parcel in a quicker manor. The DNR would then purchase from. PTCM was able to negotiate with the landowner to not only acquire the 20 acers but an additional 40 acres. That helps close out the western park boundary and limits the number of future transactions with this landowner.

Fourth Update September 1, 2021: PTCM is still working on negotiations with the landowner.

Fifth Update March 1, 2022: PTCM has officially acquired the property. Now the DNR is working on acquiring from PTCM. Appraisal has been received preparing the option to provide to PTCM.

Amendment Request April 21, 2021: Requesting to add this additional activity due to other activities not utilizing their full appropriated amounts. As of today, PTCM has signed the option and we have requested the abstract of title commitment.

Sixth Update March 1, 2023: The lean has yet to be satisfied. It has been made clear that it will be satisfied this spring. It was also found that there is a pipeline easement on the property. The landowner is working with the utility company to clean up the easement language prior to becoming the State's property. The acquisition is on track to close by fiscal year end.

Amendment Request May 19, 2023: Seeking an amendment to extend the appropriation for this activity for one year. Currently this project the funding has been encumbered, there is a signed option, and a request has been made for the abstract of title commitment. There is still a chance this project will be closed by fiscal year end. An easement with a utility company was discovered during the project and there is a need to get some easement language cleaned up before the state can acquire the property. Due to the lack in response from the utility company it is unsure this project will close by fiscal year end. These conversations have been taking place since fall of 2022. Amendment Approved by LCCMR 6/21/2023

Seventh Update September 1, 2023: 59.97 acres were acquired on June 21, 2023. The property is currently undergoing site cleanup to start restoration efforts.

ACTIVITY 7 Title: Minnesota Valley State Trail, Scott County, 5 acres

Acquiring the property would allow PAT to freely act on maintenance concerns that occur on the section that we own as an example having access for equipment for repaving, adding a culvert, storm cleanup, emergencies, etc. The bluff portion contains a relatively diverse terrace forest containing oak, basswood, cherry, hackberry along with some elm and boxelder.

VII. LONG-TERM- IMPLEMENTATION AND FUNDING:

Acquire critical in-holding parcels located within statutory boundary and included in the master plans of State Parks and State Recreation Areas and acquire in-holdings of land located within statutory authorized and included in the master plans State Trail corridors. The state currently owns about 85% of the 268,000 acres within State Park and State Recreation Area boundaries, which means the state does not own, and manage on behalf of the citizens of Minnesota. Each year approximately \$5 million worth of private in-holding parcels inside the statutory boundary will become available from willing sellers.

With the continued support of the LCCMR, the Department of Natural Resources-Division of Parks and Trails expects to keep moving forward to fulfill each of the 75 state park and recreation area master plans and acquire critical parcels within statutory boundary for preservation, recreation, education and habitat restoration on behalf of the public. These land acquisitions positively contribute towards local community economy.
