#### **Sound bite of Project Outcomes and Results**

A single track mountain bike trails have been created at Belmont Park just North of Jackson, MN! The grant allowed us to build 4-1/2 miles of natural surface biking trails in the unique terrain setting near the Des Moine River. Bikers riding the trails are pumped and thankful!!

### **Overall Project Outcome and Results**

This grant built the first natural surface single track bike trail in Southwest Minnesota. The grant funded the building of over 4.5 miles of trails, which were created to add to the existing 0.75 mile grass trail which had been previously built by trail members. There is now a 0.75 mile beginner trail to encourage new bike enthusiasts to experience riding in the trees. Trail Source, Inc. was the contractor who built the additional 4.5 miles of trails. We now have an intermediate level 1.3 mile riding trail that has several switchbacks and jumps and our signature "bobsled" portion, making it a thrill for bikers to go downhill making several turns. The trail was created in a way that riders could work their way back up hill and return to the "bobsled" or very easily ride the intermediate trail again to build up endurance and learn some jumps. The more advanced trail, which is 2.6 miles long and is located past the stream, gives riders quite the workout. It starts with several uphill switchbacks, then transitions to ups and downs with more jumps located throughout. The trail

ends with a nice ride along the Des Moine River with picturesque views.

Signs were installed to indicate the location of the park off of Highway 71. Picture in attachments. The driveway/parking area was improved and the roof on the shelter house was upgraded to metal. Our first event was our open house celebration of the trails on June 7th, 2023 and drew 47 visitors. Pictures in attachments.

### **Project Results Use and Dissemination**

Several radio and newspaper articles were written about the improvements to the park. See example in attachments from BIKE MN Trails magazine.

Acknowledgment of funding from the MN Environment & Natural Resources Trust Fund has been made through radio, paper, social media such as Facebook and our county webpage, as well as on our entrance sign to the park. Already a dozen volunteers are in assisting in maintenance of the trails in addition to our annual county parks budget. We are tracking the amount of bikers daily starting in July. The competitive bike team is searching for a coach.

### **Narrative**

**Project Summary:** Create a single track mountain bike trail in SW MN where there is a current need for such infrastructure to boost economic and lifestyle changes.

### Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

This opportunity will create the "first of its kind" off road trail in SW MN. Currently one needs to travel up north to experience the thrill of single track. Biking in our community is a "life style change" that many residents in our area feel strongly about. A group called Friends of the Jackson County Trails began in 1998 and since then the addition of some concrete as well as many more miles of paved walking and biking trails have been built, totaling 14.5 miles!. We have been working three years now to make this project a reality. Some volunteer efforts for the beginner trail have been seen last summer with the opening up of the .60 mile easy beginner trail. Then we asked area biker to come out and "pack" the trails down while experiencing a small thrill of what actually will get built when the funding is obtained. School Districts, Businesses, and out of town newspapers are taking notice of our initiative to strengthen the community!

Location of trails would be Belmont Park, in Jackson County. Build to meet National Interscholastic Cycling Association (NICA) Standards. This would immediately bring our location in SW MN to be comparable to other single track places within greater MN. In communities such as Crosby, Ironton, and Riverton, MN.; the creation of Cuyuna Mountain Bike Trails have resulted in new businesses within the community getting established. This new location in SW MN's "own backyard" will cater to multiple areas in this region of the state. For starters, the local communities of Jackson and Windom will have the potential to create one or two local bike teams which will be able to train locally and then compete throughout the MN High School Cycling League held during the Summer and Fall months. Because we would be the only single track within an 80 mile radius; other communities such as Worthington and Fairmont, MN as well as Spirit Lake and Okoboji, IA would travel to use the park. Finally, visitors traveling and staying in our local campgrounds would benefit as this would provide another means of recreation for them to experience while here in SW MN. Support for project is great! No issues expected.

Ensuring the building process goes according to plan so natural features at the park are preserved. When completed we will have met goals for bike users as well as hikers. Even those that like to recreate by snow shoeing, birds watching, and native flower sight seeing while enjoying the beauty of this 80 acre park set on a slight hill over looking the Des Moines River. Build a kiosk at the park which would share our counties conservation and preservation techniques; and develop on site learning activities for the mobile Prairie Ecology Bus Center which is located in Lakefield, MN.

### **Activities and Milestones**

### Activity 1: Construction of SW MN Single track trail

Activity Budget: \$152,000

### **Activity Description:**

The design of the proposed single track trails was completed by Gary Wegner in early summer of 2018. Funds were raised through a local grant to hire him and this will be a non-ENRTF .Public Support for bike trails at this location began at a public hearing on August 6, 2018. Comments were mostly positive and supportive of the project. The only concerns brought up was need for a larger parking lot and possible fence which would act as a screen for the nearby resident in nearby proximity of property. After this meeting the local trail group has advocated at other public community events and have gained additional support within the local as well as the regional. Grants were applied for in 2019 and again in 2020. Public is excited! No further issues expected. The scope of project when completed will be 6 miles of single track trail built through the entire 80 acre wooded property. Dependent on weather, construction of trails is expected to be six to eight weeks. Upon completion park staff will place the necessary trail signs and updated road signs promoting the new park amenities. The creation of 1-3 area school bike teams would then begin.

We will advertise through local and multi state opportunities such as newspapers, magazines, radio, and on-line social media platforms. We will proudly create a sign with the trust fund logo and post at our park. Any single track publications our local trail committee makes for handling out will have the trust fund logo on it as well. Our community holds annual bike events such as the Sanford Tri For Health Triathlon, bike repair and give away days. We will continue to use trail monitoring counters to give us an accurate amount of trail usage as we currently do for our paved biking/walking trail throughout the county of Jackson. We will work with area schools to assist them in creating teams to train at our single track track. We will also work with our area health partners; those businesses such as Sanford Hospital to advocate for a healthy lifestyle change. Incorporating the opportunity to getting outside and riding a bike on our trails, then enjoying the natural surroundings our park has to offer. Our participation numbers for the above events would be documented and shared with county board every year as part of the annual parks report.

## Long-Term Implementation and Funding

Location for the trails has been provided by the county in the form of an already owned 80 acre park. Equipment of grader and time of staff will be provided at counties expense for improving road access to park and shaping a larger parking lot. Funds generated by small grants and donations from local health representatives were given to Friends Committee to pursue a designer and pay for the design of trails. Continual trail maintenance will be funded by the county in there annual budget as well as an expected volunteerism effort from users of Park and Friends of Jackson

### **Overall Update**

With word spreading that construction was finally occurring and my role everyday supervising the contractors on-site, I was able to meet several locals and visitor to the park. Some were hikers. ### **Activity 1**

4.37 Miles of single track mountain bike trails were constructed by Trail Source during the months of May through September, 2022. Local Jackson bike group installed brown fiberglass trail markers indicating names of trails and alerting bike riders of jumps and turns in October. A local bike team was formed in its initial year called the West Fork Composite. The team competed in several of this seasons MN Cycling Associations races throughout the state. The team as well some local bike enthusiasts did late Fall get to experience the new trails which were built out at Belmont. Because of some dry conditions late Summer some additional trail work will need to be finished in the spring of 2023 prior to our grand opening of the park. Detailed Maps, park signs and kiosk to be completed during the winter.

#### **Activity 2**

A new roof was installed on the shelter house. A new hand pump was installed which provides fresh water for cleaning. The turn around area inside the park was widened a bit in the Fall. Additional work on the roadway into park and creating parking stalls for visitors will be finished late Spring 2023.

### **Overall Update**

Our local Friends of Jackson County Trails group and the local towns surrounding Belmont Park have been looking forward to 2022 and seeing the construction start for the single track trails. With construction slated to begin this week it is finally here! Was decided to apply for an amendment so projects originally slated for Activity 2 in project would be absorbed by county funds so additional money could be allocated for the completing of the trails.

### **Activity 1**

Trail contractor has a scheduled start date of May 20th, 2022

### **Activity 2**

Building new picnic tables has been completed. Roof replacement for shelter house is scheduled to occur before June 28, 2022. Parking areas have been established and final gravel will be applied after trail contractor is finished with building trails.

As outlined in our proposed amendment, the above items will be removed from the grant total so additional money can be used on completion of more trails

#### Dissemination

We have updated our county web page to include the "LCCMR loon logo" and indicate that upcoming trail work will be beginning in 2022 thanks to a grant received from the Environment and Natural Resources Trust Fund. In a recent May newsletter publication with the local Jackson Pilot newspaper, recognition of where funds were coming from for the building of single track trail at Belmont occurred during an interview/ update on county parks activities this summer. We have just received a sign which will be posted near park later this month. A local bike team has been organized from the area to start training in July and compete as a team this Fall through the MN Cycling Association. Other local training events through the local school district has been scheduled.
