Narrative

Project Summary: Acquire top priority in-holdings within legislatively established boundaries of Minnesota's 75 State Parks and State Recreation Areas and 26 State Trails from willing sellers.

Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

This proposal represents an investment in the future, fulfilling legislative direction to acquire parcels from willing sellers within the 66 legislatively authorized and defined state parks, 9 state recreation areas and 26 state trails and trail systems. Presently, the Minnesota Department of Natural Resources (MN DNR) does not own or manage approximately 15% of land located within the legislatively approved and statutorily described State Park and State Recreation Areas and only approximately 50% of the land needed to complete the 26 legislatively authorized State Trails. This project when complete will protect significant natural and cultural resources located within Minnesota's State Parks and along the State Trail corridors, provide positive economic impacts and enhance outdoor recreation opportunities. Given the nature of the identified Minnesota state park and trails properties, they are infrequently available and purchase opportunities can limited and time sensitive. Interested sellers often wish to include their family's treasured property as a part of a State Park or Trail for the public to enjoy in perpetuity. If funding is unavailable to pursue an acquisition at the time the property owners decide to sell, the property is at risk to be subdivided, developed or taken off the market for decades.

This project proposes the acquisition of up to 12 separate properties, located within 4 State Parks, 1 State Recreation Area and on 6 State Trails in an effort to fulfill the specific legislative authorization. The four State Parks represented include Crow Wing, Gooseberry, Lake Maria and William O'Brien. If successful these four acquisitions would result in the acquisition of a total of 59.5 acres within these parks. At the Minnesota Valley State recreation Area there is an opportunity to acquire up to 800 acres which would provide for a significant expansion of developed use areas. A total of 7 properties have been prioritized for acquisition on 7 separate State Trails, including the Blazing Star, Blazing Star, Casey Jones, Cuyuna Lakes, Mill Towns and Taconite. These acquisition would result in the addition of approximately 9 miles of new state trail corridor, containing approximately 40 acres. These properties have been identified and ranked by the MnDNR Division of Parks and Trails. The MN DNR maintains, reviews and annually updates a general statewide priority list of willing sellers and potential projects that address investment criteria established in the DNR Parks and Trails System Plan. Non-ENRTF funding will fund all transaction costs.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

The successful acquisition of the 12 identified properties, 4 within State Parks, 1 in a State Recreation Area and 6 along State Trail corridors will result in expanded natural and cultural resources protection over more than 875 acres, as well as additional environmental educational programming, increased economic activity in surrounding areas, and enhanced outdoor recreation opportunities to engage generations of residents and visitors in Minnesota's great outdoors. Within the exception of areas noted to contain significant and vulnerable natural and/or cultural resources, most properties would be immediately available for limited public use upon the State securing ownership.

Activity 1: State Park and Recreation Area Inholdings

Activity Budget: \$5,094,000

Activity Description:

This project proposes the acquisition of several high priority property in-holdings located entirely within the boundaries of state parks and State recreation areas. Each of the defined properties, reflect priority opportunities to conserve and protect substantial areas that contain rare, unique, or high-quality natural resource communities and areas of significant biodiversity while also expanding the potential for public recreational access to areas that are currently privately held. The priority properties to be considered for acquisition under this project are proposed in William O'Brien, Crow Wing, Lake Maria, Gooseberry Falls State Park and Minnesota Valley State Recreation Area. The acquisition of each of the individual properties will require the completion of formal appraisals and/or property valuations, deed and title examinations and physical boundary surveys where necessary. Is some cases, existing property improvements may require demolition, removal and cleanup need following the conclusion of the property acquisition. It is generally anticipated that each individual property acquisition will take between 18 and 24 months to complete. Should any of the identified acquisitions fail to proceed, the MN DNR may request an amendment to the Project Workplan that will identify a replacement property selected from the Parks and Trails statewide priority list

Activity 2: Legislatively Authorized State Trails

Activity Budget: \$331,000

Activity Description:

Acquire high priority in-holdings along legislatively authorized state trails from willing sellers statewide to fulfill master plans throughout the State of Minnesota. The proposed state trail property acquisitions represent opportunities to secure properties which connect existing state trail segments, extend legislatively authorized state trail corridor consistent with approved Master Plans, to address user safety or remedy environmental conditions. Identified properties include potential parcels along the following State Trail corridors: Casey Jones, Cuyuna Lakes, Arrowhead, Taconite, Blazing Star and Mill Towns State Trails. Priorities corridor acquisition along the Casey Jones, Cuyuna Lakes and Mill Towns State Trails are focused on securing properties that addresses gaps in existing public ownership. The identified properties on the Arrowhead, Taconite and Blazing Star State Trails will address required revisions to existing developed trail corridor or trail use or to eliminate conflicts with non-public properties. Should an identified acquisition be unsuccessful, the MN DNR may request an amendment to the Project Workplan that will identify a replacement priority property that could be located on any one of the legislatively authorized State Trail corridors. Is some cases,

existing property improvements may require demolition, removal and cleanup need following the conclusion of the property acquisition.

In association with State Trail corridor acquisitions, the participation of the LCCMR will be acknowledged at appropriate trailhead signs and the ENRTF logo attached to primary entrance signs.

Long-Term Implementation and Funding

Each of the properties identified for potential acquisition are located within or along existing state park or state recreation area boundaries or along authorized state trail corridor that are currently administered, operated or maintained by the MnDNR. The operations of State Parks, State Recreation Areas and State Trails are funded through a variety of State Funding. The LCCMR and ENRTF funding has and continues to provide a significant source of support for State Trail development and rehabilitation. Other sources of operational state funding for these facilities include Legacy, Land and Water Conservation Fund, Capital Bonding and several dedicated sources.
