Narrative

Project Summary: Engage 28,000 Minnesota youth in outdoor experiences that create a love for the environment.

Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

The projects proposed remove barriers for young people to connect them to meaningful outdoor experiences through YMCA of the North camp programs which include day camp (ages 5-17), overnight camp (ages 7-17), wilderness trip experiences (ages 12-17); and outdoor learning experiences for schools (grades 1-12) and youth-serving community partners. These experiences range from one-day experiences, week-long experiences and multi-week wilderness trips for older youth (ages 12-17).

Many Minnesota youth do not access engaging nature-based opportunities that build academic and social growth, resiliency and a love of the environment for reasons of program fees, transportation, knowledge of opportunities and/or fear of physical and psychological safety in nature-based settings. Additionally, as we have increasing concerns for the conservation and preservation of pristine wilderness, clean water and unpolluted air we need to include the next generations in the experiences and appreciation of nature and knowledge of the global impact of losing these.

The YMCA will expand access to outdoor experiences for youth and families across Minnesota through our 16 camp locations. We propose increasing youth access to outdoor experiences through scholarships (overnight, day, or wilderness camps), field trips, classroom/homeschool engagement, and community group/family events. These scholarships will expand access to structured outdoor experiences at no cost to under resourced children and families. These programs are available year-round, allowing us to service Minnesota communities beyond the traditional summer camp model. We will introduce new generations of youth to the outdoors, fostering an understanding of the importance of conserving our wilderness. We will create a welcoming outdoor experience through the development of gear libraries, allowing us to loan critical, and potentially prohibitively expensive gear to our campers. We recognize that transportation to and from camps can be a barrier to entry for some families. Thus, we propose a transportation scholarship which will allow us to transport campers at no cost. This will eliminate the distance barriers for financially under resourced families. These programs mold lifelong stewards of nature, helping participants feel safe and supported as they explore the outdoors, enhancing hands-on learning opportunities (science in nature) and engaging science and math learning.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

- 1) Equip younger generations (28,000 youth) with knowledge and care for the environment. This includes 600 young people attending YMCA camps in Minnesota with scholarships and approximately 27,400 youth attending YMCA outdoor programming trips.
- 2) Support equitable access to Minnesota's natural resources for youth through the utilization of the YMCA's extensive scholarship program and transportation network.
- 3) Lessen the impact of YMCA camp programming on Minnesota's natural environment through the implementation of new gear libraries. With the cataloguing of gear, we can guarantee that all equipment entering the environment is returned, and nothing is left behind.

Activities and Milestones

Activity 1: Development of Gear Libraries YMCA overnight camps, day camping and for wilderness camping trips

Activity Budget: \$405,000

Activity Description:

Lending gear to meet the needs of participants from low-income communities who are ready in spirit and not ready with the right equipment and gear. A Gear Library removes barriers for participation and increases safety and meaningful experiences. The Gear Libraries will be located at six overnight camps where they are accessible to programs statewide and will be maintained. Funding Gear Libraries will include:

Funding for development of Gear libraries. 2026 \$150,000; 2027 \$100,000; 2028 \$80,000, 3 yr Total: \$330,000

Camp Gear Libraries include but are not limited to: Sleeping bags (\$20), hiking boots (\$80), rain jackets (\$20), snow shoes (\$100), backpacks (\$20), and seasonal consumables (\$10) (e.g. sunscreen, bug repellent, water bottle). Fully 35% of our summer campers and 65% of our wilderness campers receive financial aid to be able to participate. Schools have limited budgets, not equipped to provide the extras that allow students to fully experience (day or overnight) outdoors. Equipping Gear Libraries in Year 1 will allow us better purchase economy as we buy in bulk for camps. The YMCA favors local businesses for camping gear and equipment to support local economy and will work with vendor partners.

Activity 2: Financial aid to remove barriers for youth to access camp experiences at overnight, day and wilderness camp

Activity Budget: \$2,680,000

Activity Description:

YMCA will provide day, overnight, and wilderness camp experiences across Minnesota for approximately 28,000 youth. Youth participate through school group trips and individual camp experiences, and all will receive transportation assistance through this grant. Transportation assistance to and from camps will be provided to campers and school groups through contracted busses funded by this grant. The YMCA will select and contract bus providers based on location and cost.

35% of individual campers also require scholarships to participate. We will provide full or partial scholarships for 200 campers per year. Our scholarship application is accessed online where campers use an estimator tool to see if they qualify for aid and submit income documentation. Applications are reviewed for completeness, accuracy, and approval. If a scholarship is denied, families can pursue an exception process for further consideration. We track all of awards, allowing us to document information provided including household size, income, the award amount, additional notes, and whether it's an exception.

The YMCA is committed to providing all individuals access to opportunities that promote positive youth development, health and wellness, and social responsibility. To do this within our camps, we will provide expanded opportunity to underserved populations and increase the capacity of our camps and programs to provide gear and transportation in addition to financial aid. Establishing gear libraries, transportation to and from camp and supporting costs of schools to access Science in Nature programming removes barriers for high needs youth. Outcomes demonstrating the positive impact of these outdoor experiences will provide evidence for future funders and our sustainability.
