MAIN PROPOSAL

PROJECT TITLE: Lake Marion Shoreline (3,300 feet) Acquisition

I. PROJECT STATEMENT

As guided by Lakeville's Parks, Trails, and Open Spaces System Plan, several acquisitions on Lake Marion have been accomplished during the past 20 years. Two priority sites remain: one 11-acre site consisting of approximately 480 feet of shoreline and one 60-acre site known as the Bury property consisting of 3,300 feet of Lake Marion shoreline, upland bluff, and forest areas. Acquisition of the Lake Marion shoreline consisting of approximately 20 acres will complete a linear greenway corridor loop adjacent Lake Marion consisting of approximately 2.73 miles of public lakeshore ownership. The property is being considered for development although sewer will not be available until 2015. Purchase of the property would allow Lakeville to construct a greenway corridor trail with regional significance and complete a trail project around the entire 550-acre basin of Lake Marion, connecting several major parks, fishing piers, boat launch, major residential and commercial areas, and an existing MN Department of Transportation park and ride facility.

The goal of the project is to acquire 20 acres on Lake Marion consisting of 3,300 feet of shoreline, bluff areas, and associated upland oak savannah. The project also seeks to preserve and enhance an ecological corridor consisting of upland oak forest, flora, and fauna. The site is identified in the Minnesota County Biological Survey as an oak openings and barrens site. Finally the project will assist with maintaining the high water quality in Lake Marion through creation of a substantial buffer zone between proposed residential development and Interstate 35W. The proposed trail corridor is identified as a future regional trail corridor in the Dakota County Parks Open Space Plan and the Metropolitan Council 2030 Regional Park plan.

Lakeville's population is 54,000 with estimates to be 90,000 by 2030. Lake Marion is the largest natural lake (550 acres) in Dakota County, providing high quality, public recreational opportunities for residents throughout the metropolitan region. The proposed acquisition and trail construction will have little to no impact on existing resources or various species presently on site. Proposed trail construction will be in an area previously disturbed by past mining activities. The Lake Marion shoreline and bluff areas will be preserved in their natural state. Acquisition will put the proposed shoreline and bluffs in public ownership. Stewardship activities would include forest health management, eradication of exotic species, erosion control improvements, shoreline stabilization, and planting of native grasses and trees.

II. DESCRIPTION OF PROJECT RESULTS

Result 1: Acquisition of 20 acres adjacent Lake Marion Budget: \$1,030,000

III. PROJECT STRATEGY

A. Project Team/Partners

The following team/partners are involved in the City's initiative to acquire the project site: the Minnesota Department of Natural Resources, Metropolitan Council, Dakota County, Lake Marion Homeowners Association, Lakeville City Council, and the City's Parks, Recreation and Natural Resources Committee. City staff members will manage the application process from start to finish. They include Gerald S. Michaud, who will serve as Project Manager, and John Hennen who will serve as Project Supervisor.

B. Timeline Requirements

This unique acquisition/process will attempt to coordinate several grant applications utilizing the Department of Natural Resources, Metropolitan Council, Dakota County, and the City of Lakeville funding sources. Through grant applications and matching City funds, it is the City's hope that sufficient funds will be allocated to acquire the proposed 20-acre parcel. Grant award announcements range from mid-summer 2009 through the current enhancements application RFP for 2014 funding. The City is hopeful that enough funding can be allocated to complete the acquisition by the fall of 2011.

Project Manager Qualifications and Organizational Description

Steve Michaud, the City of Lakeville's Parks & Recreation Director for the past 35 years, will act as project manager. Mr. Michaud has written several successful grants through various agencies. They include: the Land and Water Conservation Fund, Natural and Scenic Areas grant program, Local Trails Connections program, Snowmobile and Ski Trail Grant-in-Aid programs, Dakota County Farmland and Natural areas grant program, Outdoor Recreation Grant program, State Park Road Account program, Federal Recreation Trail program, Fishing Pier grant program, and the Minnesota Re-leaf program.

Mr. Michaud will coordinate grant preparation and submittal, present testimony to the LCCMR concerning the 2010 proposal for \$1,000,000.00, coordinate communications and monitor grant agreement authorizations between the State of Minnesota and the City of Lakeville, monitor negotiations between City attorney and land owner, and supervise all aspects of the proposed acquisition of 20 acres on Lake Marion.

Mr. Michaud represents the City of Lakeville Parks and Recreation Department, which consists of 58 active, developed parks, 18 conservation areas, and 5 greenways. In total, these areas consist of approximately 1,400 acres. The City has a population of 53,000 with anticipated growth to 90,000 by 2030.
