2011-2012 MAIN PROPOSAL

PROJECT TITLE: Springbrook Nature Center Natural Resource Management Education

I. PROJECT STATEMENT

Springbrook Nature Center in Fridley, MN, is requesting funds to educate hundreds of volunteers while accomplishing comprehensive natural resource management needs. Volunteers and program participants from business groups, colleges, community groups, court services, elementary, middle, and high schools currently participate in conservation activities at Springbrook. The proposed project will enhance the educational aspects of these activities, helping participants to accomplish activities more efficiently and effectively, and to gain and take away a greater understanding of natural resource conservation.

With the proposed project, Springbrook will create educational materials, curricula, and a Natural Resource Management Plan. By integrating these resources into educational activities for volunteers, Springbrook will teach volunteers diverse environmental concepts and provide an immediate opportunity to apply that new knowledge through hands-on work activities. In addition to meeting education objectives, through this project Springbrook will improve management of native and non native plant and animal species as well as invasive species, use volunteers more effectively and efficiently, leverage the completed plan to secure future support for ongoing implementation, and be a model for other centers to use. The goals of the project are:

- 1) Develop formal educational curricula for school classes in which students address graduation standard content by participating in natural resource management activities such as buckthorn removal, stream water analysis, erosion control, or wetland seed distribution.
- 2) Develop informal educational opportunities focused on learning natural resource management concepts and practices but not focused on addressing graduation standards.
- 3) Develop non-formal educational material focused on natural resource management. Participants including business employee groups, scout groups, civic organizations, court appointed "sentence to serve" community service individuals, and the general public will learn about conservation and natural resource management topics and techniques.
- 4) Develop a comprehensive Natural Resource Management Plan that integrates diverse volunteer educational experiences to implement significant portions of the plan.
- 5) Improve the efficiency and effectiveness of natural resource management at Springbrook.

The project will achieve these goals by creating educational curricula and materials, contracting with a professional to develop a Natural Resource Management Plan, developing and delivering educational opportunities, and educating volunteers to complete natural resource management activities. Volunteers will be able to see how their isolated work activity fits into an overall plan that accomplishes significant goals, and how skills they have learned can be used in their business, home, community, and other settings beyond Springbrook Nature Center.

II. DESCRIPTION OF PROJECT ACTIVITIES

Activity 1: Develop a Natural Resource Management Plan Budget: \$5,000

Springbrook Nature Center will execute a contract with John Moriarty to develop a comprehensive Natural Resource Management Plan. Moriarty will use the Minnesota Land Cover Classification System (MLCCS) to categorize the land cover in the Nature Center. Moriarty will also categorize management activities into those that can be conducted by volunteers and those that require professional help to implement (e.g. controlled prairie burns).

Activity 2: <u>Develop and integrate education activities in the Natural Resource Management Plan Budget: \$10,000</u>

Springbrook Nature Center's Interpretive Program Supervisor Tara Rogness will develop curriculum components for educational opportunities to align with the Natural Resource Management Plan and will implement the plan.

Activity 3: Conduct and evaluate natural resource education activities Budget: \$31,000

The Nature Center will hire a .2 FTE Natural Resource Educator to develop educational natural resource management programs and opportunities specific to volunteer and school groups. The Educator will also coordinate scheduling of volunteer/student groups, educate volunteers, and conduct educational natural resource management activities throughout the spring, summer, and fall seasons. Springbrook will secure a contract with a web-design professional to develop educational online activities for schools to use pre- and post-assessment opportunities for schools, and natural resource management educational information for volunteers.

III. PROJECT STRATEGY

A. Project Team/Partners

- Siah St. Clair, Springbrook Nature Center Executive Director, will oversee the development, coordination, and completion of the Natural Resource Management Plan and its activities.
- Tara Rogness, Springbrook Nature Center Interpretive Program Supervisor, will plan and implement educational components of the project.
- John Moriarty, Natural Resource Management Planner, will be contracted to develop the comprehensive resource management plan.
- Springbrook Nature Center Natural Resource Educator (TBD) will schedule and conduct volunteer natural resource education activities.
- Springbrook Nature Center Web Designer/Outreach personnel (TBD) will create education and post-assessment activities for schools, individuals and volunteer community groups.

B. Timeline Requirements

The project runs July 1, 2011 through June 30, 2013. Natural resource management and educational planning will be completed in the first four months. Implementation of natural resource educational activities will be ongoing November 1, 2011 to June 30, 2013 and beyond.

C. Long-Term Strategy and Future Funding Needs

Initial investment in the Natural Resource Education/Management Plan and the momentum from its two year implementation will allow Springbrook Nature Center to leverage this plan for volunteer hours and philanthropic dollars for many years to come. Ongoing costs after the project period will include the implementation of volunteer educational activities, supplies, and some administrative expenses. With the continued support of the City of Fridley and Springbrook Nature Center Foundation, the Nature Center will secure new and additional philanthropic funds to sustain the ongoing implementation of the Plan. Springbrook's existing operating budget will sustain a minimal continuation of this plan.
