PROJECT TITLE: America's Great Outdoors (AGO) Minnesota River Corridor Enhancement

I. PROJECT STATEMENT

Intensive work by non-governmental organizations (NGOs) in the MN River Valley and recent federal recognition has resulted in an increased demand/need to focus on the upper 185 miles of the Minnesota River valley. High citizen and agency focus in this area is partly due to the high quality and large amount of remaining native plant communities.

Three main project goals in this scenic corridor are to: 1) Improve water quality and biodiversity through protection and restoration of high quality habitats in the River Valley and its watershed, 2) Increase the many types of outdoor recreational opportunities, and 3) Increase awareness and stewardship of the intrinsic cultural and natural features.

This initiative works towards creating a rich mosaic of public and private conservation lands connecting local communities and visitors with public lands and waters; natural areas; and scenic, historic and water trails and byways. Restored riverine and prairie habitat will provide cleaner water for fish, wildlife and people. Enhanced recreational experiences and learning opportunities about the river's natural and cultural history will be available to visitors. This restored and shared landscape will attract new users and businesses, providing economic vitality and a better quality of life in the region.

Project Summary#

Conserving natural and cultural resources; restoring critical habitats; improving water quality and optimizing recreational opportunities benefits residents and visitors of the Upper Minnesota River while positioning the corridor for a National Blueway designation. Leveraging partnerships between government units, NGOs, Tribal communities, and landowners to implement restoration strategies along with working lands approaches will result in connecting more people to the Minnesota River Valley thereby increasing the stewardship potential in this unique region of our state.

II. DESCRIPTION OF PROJECT ACTIVITIES

Activity 1: *Citizen and Business Engagement*

Engage corridor residents, recreational users and businesses to complete Blueway designation implementation plan, recreational gap analysis and 4 site designs that are cost-effective, environmentally sustainable and of high recreational value. Results will form the basis of a 2 year implementation plan for corridor partners.

An electronic version will be easily available and user friendly.

III. PROJECT STRATEGY

A. Project Team/Partners

Project Coordination Team (contributing in-kind): DNR Southern Region Planner, DNR Southern Region Parks and Trails Strategic Program Manager, DNR Southern Region Regional Director

B. Timeline Requirements

CCM contracts run February through December. Follow-up activities for this project will keep CCM positions constructively employed through December 2015. Development activities on acquisitions will require a full field season through mid-November 2015.

C. Long-Term Strategy and Future Funding Needs

The upper Minnesota (MN) River has long been recognized for its ecological, recreational and scenic values. The river received MN water trail designation in 1963 and MN Wild and Scenic River status in 1977. In 2010, two documents – "Conservation in the Middle Minnesota Valley: A Blueprint and Action Plan" and "Minnesota Prairie Conservation Plan 2010: A Habitat Plan" – identified strategies, regionally and statewide, which will be employed in the project area. This proposal is also a component of a new effort to establish a National Blueway on the upper 185 miles of the Minnesota River (approximately New Ulm to Ortonville). Initial national recognition for this project was received fall 2011 through the AGO Initiative. An AGO 12-month workplan was submitted in partnership with the USFWS January 2012 (this will help focus existing federal funds in the project area). It is anticipated there will be additional funds needed from a variety of sources to complete the recommended actions for the above work/ action plans and eventual Blueway designation. Future investments include additional permanent land protection in key areas to provide contiguous habitat/recreational corridors and water quality improvements; increase and upgrade of recreational infrastructure; and trail development. DNR and corridor partners will continue working together to insure a coordinated approach towards a common vision and increased stewardship of the unique resources in the valley.


