PROJECT TITLE: Citizen Input on Silica Sand Mining

I. PROJECT STATEMENT

With the demand for Silica Sand increasing, Minnesota is at a critical juncture where important decisions with long lasting environmental and economic impacts will be made. The state has already allocated funds to examine the impact on silica sand mining (e.g. the Minnesota Environmental Quality Board and Goodhue County have both commissioned studies), yet little has been done to inform and include local populations in decision-making processes over frac sand mining. Without data-driven, defensible decisions understood by the wider community, this issue will continue to divide communities and make policy decisions difficult to implement.

Citizen Input on Silica Sand Mining will result in the St. Charles and Wabasha areas having a framework for evaluating the opportunities and potential drawbacks of silica sand mining in southeast Minnesota. The project will directly result in improved communication between policymakers, stakeholders, and the general public regarding conservation efforts and options surrounding silica sand mining leading to easier implementation of policies. More generally, the project will model civil, citizen inclusive debate surrounding divisive environmental and economic policies.

The Jefferson Center will draw on its 40 years of expertise in citizen engagement to bridge the divide between policymakers and local residents resulting in better policy and better educated citizens. In running two, three-day civic engagement events known as Citizens Juries (one event in St. Charles, one event in Wabasha), the staff of the Jefferson Center will: 1) enlist the participation of 24 randomly selected citizens; 2) secure participation of experts and policymakers on both sides of the frac sand mining debate to provide balanced background *from and for* local communities about the potential environmental and economic tradeoffs associated with silica sand mining; 3) arrange a space for informed deliberation and citizen-led recommendation writing on policy options related to silica sand mining; 4) publish and distribute citizen recommendations to every household in the respective communities while working with local media to advance continued informed dialogue on silica sand mining. The civic engagement events will be bookended with pre and post surveys to provide policy makers with a snapshot of the broader public attitudes.

II. DESCRIPTION OF PROJECT ACTIVITIES

Activity 1: Development and Facilitation of Citizen Jury Events Budget: \$ 53,981

Civic Engagement will consist of two (2) Citizens Juries (one in St. Charles, one in Wabasha) consisting of randomly selected panels of citizens residing within those geographic areas. Panelists will evaluate expert testimony from advocates on a broad range of perspectives on silica sand mining. The panelists will deliberate to identify recommendations on local and sate regulatory powers, landowner rights and economic concerns related to mining expansion. The result will be a report, written by the citizen-panelists, to explain the options to their neighbors. Prior to the event, the Jefferson Center will conduct a survey measuring baseline attitudes related to silica sand mining.

Activity 2: Publication of Citizens' Recommendations

Citizen recommendations on silica sand mining expansion gathered by the panelists, along with their summary report, will be compiled into a briefing packet for policy makers, local news media, and mailed to every household in the affected communities. The Jefferson Center will concurrently run a post-event public awareness survey measuring public attitudes on silica sand mining and analyzing any change from the baseline attitudes measured in Activity 1.

III. PROJECT STRATEGY

A. Project Team/Partners

Receiving ENRTF Funds

- Jefferson Center staff will research, network, and implement Citizen Jury events and will design and
 analyze survey results. The Jefferson Center has nearly 40 years experience designing and implementing
 civic engagement events on issues ranging from Agricultural Effects on Water Quality to Healthcare
 Reform. Due to the small number of Jefferson Center staff, Co-Directors Larry Pennings and Kyle
 Bozentko will serve as Project Designer and Project Manager, respectively. Dawn Dettinger will serve as
 Project Coordinator.
- The project will enlist professional moderators to facilitate a civil, informed discussion on silica sand mining.
- The project will also require a mailing and survey company for participant selection as well as pre and post event surveys.

Resources from other sources

Dovetail Partners will provide research and project development assistance in an advisory role. Dovetail
has expertise in providing authoritative information about the impacts and trade-offs of environmental
decisions such as consumption choices, land usage and policy alternatives.

B. Timeline Requirements

No unique timeline requirements—project to be completed within 12 months of fund distribution.

C. Long-Term Strategy and Future Funding Needs

This project will serve as a methodological decision-making framework and data-driven informational resource for Minnesota communities facing complex natural resource development opportunities. Future project could apply the tools developed through this initiative to build long-lasting, citizen-led policy recommendations and planning strategies.


