Project Title: River Watch on the Minnesota River

PROJECT TITLE: River Watch on the Minnesota River

I. PROJECT STATEMENT

1. WHY this project needs to be done; The Minnesota River contributes a vast majority of the sediment (over 80%) being deposited in Lake Pepin and other areas of the Mississippi River. There is no basin-wide body or watershed entity collecting data and overseeing goals for river sediment reduction or for water quality improvement. Data will be collected in accordance with and reported to the MN PCA. Building a stronger awareness and public support for river water quality improvement and associated land management improvement is essential if the Minnesota River water quality and sediment issues are addressed successfully. Friends will establish a River Watch program in the Minnesota River Basin modeled after the successful River Watch program operated by the International Water Institute on the Red River.

2. Overall GOALS

One: Create and operate a Minnesota River Basin-wide River Watch Program that includes high school based River Watch clubs trained to conduct monitoring using PCA protocols

Two: Create all materials, necessary to recruit high school based River Watch teams and a marketing/engagement plan to recruit the initial 15 high school based River Watch teams.

Three: Train River Watch team leaders and have teams complete three years of river monitoring, data collection, and other activities.

Four: Create a cadre of young people, future leaders, dedicated to and experienced in working together to improve water quality and preserve the natural resources of the Minnesota River Basin

II. PROJECT ACTIVITIES AND OUTCOMES

Activity 1: Develop a basin wide River Watch Minnesota River program plan. This work to be completed after the ENRTF application deadline but prior to ENRTF funding. This will be funded from non ENRTF other sources. Work performed from July 2016-June 2017 will involve planning, development of promotional materials and a School Team River Watch Planning Tool, contacting schools to establish and enroll River Watch Teams, and building a structure for ongoing support and operation of the River Watch Program.

III. PROJECT STRATEGY

A. Project Team/Partners

Friends of the Minnesota Valley-Project Sponsor providing staff oversight by its Executive Director. International Water Institute-technical advice and guidance

Lower Minnesota Watershed District-Funding for planning year, possible funding for future years Izaak Walton League of Minnesota funding for planning year and promotion of program to schools Local School Districts in the Minnesota River Basin-Hosts for River Watch Teams

American Fisheries Society/MSU, field guidance by graduate students in data gathering and analysis

B. Project Impact and Long-Term Strategy

At present there is no effective basin wide project, program, unit of government, or other effort. That creates a single voice or common agenda for the Minnesota River Valley and basin. This results a lack of comprehensive data on water quality and soil erosion. This project will not only provide reliable data, but will raise public awareness and build a cadre of young people and future leaders in the basin who have experience working together and who view the environmental problems of the river through a common lens.

This project will provide a hands-on learning experience to hundreds of students in dozens of school districts. Over time, River Watch team work will expand and grow to include examining sources of sediment and water pollution and advocating on a local level for Best Management Practices to address those concerns.

Activities to occur during fiscal years 2018, 2019 and 2020 will be funded with ENRTF funding plus financial support from Friends of the Minnesota Valley and other local funders for anu unforeseen expenses.

Programming that begins in FY 2021 and continues will be supported by more aggressive fundraising, some of which will occur during the project period, but may require continued funding from the ENRTF or similar sources. Funding in FY 2021 and beyond from local sources including watershed organizations in the Minnesota River basin will be achievable because tangible results in the form of data, active school based teams, and the annual conference/forum.

Sponsoring Organization: Friends of the Minnesota Valley Organizational Description

The Friends of the Minnesota Valley is a non-profit, 501c3 organization based in Bloomington Minnesota. The Board of Directors includes members from the lower and middle Minnesota River. The Friends was instrumental in advocating for the founding of the Minnesota Valley National Wildlife Refuge, the lawsuit and settlement that brought the Minnesota Valley Trust into existence, and most recently led the effort to obtain legislative approval of a bonding appropriation to construct ten miles of the Minnesota Valley State Trail in Bloomington.

The Friends has several hundred members, supporters, and volunteers.

The Friends of the Minnesota Valley is one of the founding sponsor organization of the Minnesota River Congress (MRC), in that role, the Friends have received two McKnight grants to fund operation of the Minnesota River Congress.

Project Manager: Ted L. Suss, Executive Director of the Friends of the Minnesota Valley

Ted L. Suss has was one of the initial founders of the Minnesota River Congress (MRC) and serves on its Action Board. He has been a key planner of all MRC activities including developing its governing structure its goals, and operational procedures. Through this work, he has developed a wide network of contacts across the entire Minnesota River basin.

Ted L. Suss has administered grants, including an ENRTF grant for construction of a canoe landing and trailhead in Morton Minnesota, the previously mentioned McKnight grants, and numerous grants to school districts. As a School administrator and superintendent, he is experienced in financial management, program design and implementation, and contract administration.

A key for success of this project is the relationship Mr. Suss has with school superintendents, principals and other educators in the Minnesota Valley where he served twelve years as a superintendent. His knowledge of school personnel and school operations will be invaluable in recruiting schools to sponsor River Watch Teams.

River Watch Project Coordinator

The person selected for this position will hold at least a four year degree in Natural Resources, Water Quality, Environmental Education, or a similar field. The plan is to hire or contract with a person during FY 2017, using non ENRTF funding, to assist in development of the plan, become fully trained, and begin recruiting school based teams.
