#### PROJECT TITLE: Capacity Building for Rural Resource Management Implementation

#### I. PROJECT STATEMENT

This project will use our pioneering civic engagement model to implement rural priorities and solutions to key challenges for Minnesota's natural resources through a process that will generate authentic rural support for implementation. We will share these findings with policy makers and the nine state agencies that make up the Environmental Quality Board (EQB).

On many of Minnesota's key issues, particularly around natural resources, there is a unique complexity that guides rural resource management – often exclusive from urban processes for managing the same resources. Our rural citizens are tied closely to the state's natural resources both economically and culturally. Yet, too often, rural communities are pressed to respond to new policies related to natural resources – often opposing those policies – rather than at the table helping to create those policies from the beginning. Minnesota is facing major changes to ensure the protection of our water, land and air for generations to come. And there is growing action to transition toward more renewable, locally-produced energy. It is critical that rural-based priorities be identified and conveyed in the development of future policy on the state's natural resources.

For two years, IATP and the Jefferson Center – a civic engagement focused nonprofit and our partner in facilitation – have been conducting the Rural Climate Dialogues. Each 3-day dialogue is preceded by months of stakeholder engagement and identifying local experts to present testimony on community-identified issues. In September of 2016, we held a statewide convening of rural dialogue participants in St. Paul to connect them with state agency staff who provided a statewide context and resources for achieving their common goals in becoming climate resilient communities. Both the rural participants and state agency staff identified a gap in providing rural specific resources to meet the goals of Minnesota's Climate Action Plan.

This project will hold modified, natural resource specific, dialogues within each of MN's 10 non-Metro Economic Development Regions, over two years. Each dialogue of rural citizens will identify top natural resource challenges for the regions and concrete action steps. Representatives from each dialogue will present the findings to EQB members as well as policymakers with a goal of integrating these priorities into the development and implementation of natural resource-focused policy in the state. The EQB, component agencies and state legislators will also have an ongoing base of rural dialogue participants and a successfully demonstrated process for future natural resource based policy development.

#### **II. PROJECT ACTIVITIES AND OUTCOMES**

**Activity 1:** Rural Dialogues.

We will conduct 10 3-day dialogues using the IATP/Jefferson Center model, one in each of Minnesota's non-metro economic development regions.

Budget: \$350,000

Budget: \$50,000

Tasks: Identify key region-specific issues and stakeholders through research and community engagement.

Identify and engage issue experts inside and outside of each region.

Solicit dialogue participants and promote dialogue in community and media.

Upon dialogue completion, produce a report of the dialogue findings.

Goal: Participants and the broader community are empowered to engage with government in crafting rural-specific natural resource policy.

Evaluation: Pre and post dialogue surveys will be taken to measure participant change in opinion, and willingness to further engage.

We will hold follow-up meetings and events with relevant state agency staff and legislators to share the findings of the dialogues.

Tasks: Identify overarching issues that emerge among the regions.

Identify relevant policymakers and agency staff to address findings of the dialogues.

Connect dialogue participants with officials in small group and larger forum settings as appropriate.

#### **Activity 3:** Best practices for ongoing success

We will create a Minnesota specific training manual for agency and local government staff [BL1] to conduct rural engagement on natural resource based issues.

Budget: \$100,000

Tasks: Survey EQB component agencies' and select local government officials' capacity for rural engagement. Integrate current agency capacity into IATP/Jeff Ctr. Model.

Compile best practices and desired outcomes into training manual for agency staff Host series of training events to familiarize staff with the manual and process.

Goal: Our process for rural civic engagement is carried out by public officials beyond the period of the grant. Evaluation:

#### **III. PROJECT STRATEGY**

#### A. Project Team/Partners

IATP's rural strategies team will lead this project. Anna Claussen is the Director of Rural Strategies, and has been IATP's lead on our rural civic engagement work. She will oversee this project. Jim Kleinschmit is an advisor to IATP with over 20 years' experience in rural development work. Tara Ritter is a program associate who is an expert in rural natural resource management. Ben Lilliston directs IATP's Climate and Agriculture programs, under which this project falls. An additional part-time coordinator for the team will be hired as well.

We work in partnership with staff from the Jefferson Center, Kyle Bozentko, Andrew Rockway, and Camille Morse Nicholson are all facilitators of the Citizen Jury method on which our model is based. IATP will administer all funds and contract with the Jefferson Center for their services. No public-sector partners will receive funds from this project. We anticipate no additional funding for this project.

#### B. Project Impact and Long-Term Strategy

The long-term strategy of this project is to create a self-perpetuating, ongoing process for state agencies to engage rural people in developing community priorities related to the environment and natural resources. The project would build local capacity to address complex resource management issues, including water quality, land use and preservation, and any other contentious issue that requires a rural specific solution to meet statewide goals.

#### **C. Timeline Requirements**

Using the full three years available for completion of LCCMR grants will enable us to be fully exhaustive in our approach to engaging stakeholders, working in a statewide context, and putting forth quality and detail in our reporting. We are confident we can achieve high levels of quality in our work within the 36-month timeline.


