# Narrative

#### Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

This campground only has twelve existing R.V. / tent sites and is only serviced by a portable biffy with no running water. A local survey yielded results strongly wanting a modern bathroom facility. Some campers like the added benefit of using a concrete bathroom to gather in during extreme weather verses their tent or R.V. Over the last few years, the increased camping flows has seen the need to do this project soon. The county has set aside some funds in the hope that a grant can provide the additional amount needed to complete the projects.

# What is your proposed solution to the problem or opportunity discussed above? Introduce us to the work you are seeking funding to do. You will be asked to expand on this proposed solution in Activities & Milestones.

This campground has the opportunity to be expanded to meet the needs of the existing and future use of local residents and traveling-through visitors. The modern bathroom and recreational opportunities like the gaga ball pit and sand volleyball court will keep local camp users as well as the local school districts wanting to use our local facilities verses traveling across state border to other places.

# What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

Project outcomes protect visitors by providing a healthy and sanitary family friendly style bathroom /shower facility which can also act as a safer structure for campers to stay in during extreme weather events. Additional campsites among the park will be spaced generously apart creating a better means to fully experience camping in the outdoors without feeling crammed next to another campsite. The native flower plantings will aid in and be a means for others to learn about local and statewide conservation practices. The new bathroom would provide safe, hygienic sinks, showers, toilets, and changing rooms.

# Activity 1: Family Friendly six room bathroom / shower facility Installed

Activity Budget: \$94,800

Purchase a concrete modular building from HUFFCUT, Chippewa Falls, Wisconsin. The remaining costs of building will be provided by the county

## Activity 2: Add additional R.V. / Tent sites through-out existing property to meet the demand.

Activity Budget: \$67,000

#### **Activity Description:**

The proposed improvements would bring two to three campsites ADA compliant and located closest to the main central area of the campground. The new twenty two R.V. / Tent sites would have a gravel parking base and serviced with 20, 30, and 50 amp outlets to meet the growing needs of all campers. Sites would be generously spaced up to 75' apart from one another on the north side of the entrance road. The group campsites would be spaced closer and located on the south part of the entrance road. Purchase and install from Pilot Rock the fire rings and picnic tables needed.

The improvements will allow for additional use of the park by local school kids as well as our seasonal campers. Jackson County has appropriated over \$150,000.00 to go towards the bathroom facility. Additional funding of maintenance of proposed facilities will be provided by the annual park maintenance budget. Plan to have a camp host on-site once the proposed project is completed which will be another improvement from the past.

Current responsibilities for the past four years included overseeing the seasonal maintenance as well as provided planning to county board for future projects at our nine county parks as well as several miles of trails within the county of Jackson. Prepare budgets for each year and forecast capital projects within a 10-year cycle. Will be completing a LCCMR project by June of 2023 which was a 2021 LCCMR awarded project consisting of a trail builder constructing over 4-1/2 miles of natural surface single track bike trails at Belmont Park. Prior to my current job I was a Maintenace Building and Grounds Supervisor at a 400-acre private corporate conference center in Park Rapids, MN in charge of the facilities on-site. Several building and remodeling projects were accomplished during my time there.

#### Organization: Jackson County

#### **Organization Description:**

Jackson County Parks maintains nine beautiful parks equaling more than 200 acres of parkland located in SW MN. Each park has its own unique natural qualities. Five of our parks offer recreational camping. As of now our campsites are on a first-come, first-serve basis. Anderson Park is a 25-acre campground located on the west shore of Pearl Lake. Belmont Park is home to the newly installed mountain bike park featuring over 5 miles of natural surface bike trails within 80 acres of wooded hills overlooking the Des Moines River north of Jasckson, MN. Brown Park has campgrounds between both Loon and Pearl Lakes. Brown Park South has larger camping spots available as well as four small camping cabins for rent. Community Point Park sits on the east shores of South Heron Lake. Obie Knutson Park is located on the south side of Fish Lake, near Windom, MN. Robertson Park is a 46-acre park located on the southeast shore of Loon Lake. Sandy Point Park is a gem located between the communities of Lakefield and Okabena, MN.
