Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

The original Public Land Survey (PLS) was performed in the 1850's and 1860's in Cass County by the General Land Office of the United States. The GLO survey records were passed down to the State of Minnesota and the County along with responsibility for maintenance of the monuments. This may go down as one of the earliest unfunded mandates by the federal government. Because of the lack of a well funded system of maintenance this vital infrastructure is in serious need of restoration and maintenance. Approximately 30% of monuments have been reestablished and have recorded Certificates of Location along with recorded geodetic coordinates. It is the goal of this grant request to begin to make restorative progress before additional loss of corner monuments and evidence occurs.

All land title and parcel boundaries relate directly or indirectlto the PLS monuments that are set in the ground. As such the scientific management of natural resources depends on the PLS monument system along with transportation systems, taxation, and protection of shoreland resources through the administration of the shoreland and land use ordinances.

Restore and certify the PLS corner monuments in Woodrow Township, T 140 N, R 29 W with accurate GPS coordinates so the physical location can be easily restored in the future. The marking of these corners will let landowners see where the section lines are, enable private surveyors to cost effectively survey land and delineate lines for natural resource management activities. The coordinate data collected can be utilized as the foundation for creating more accurate parcel maps used for land management, taxation and land use permitting.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

The United States Forest Service, Minnesota DNR, Cass County Land Department, Cass County Environmental Services, Mississippi Headwaters Board and watershed districts are all potential beneficiaries of a fully monumented PLS system and subsequent improved parcel mapping. Knowing where the land boundaries are is an important aspect to the large-scale management of natural resources, land use, and transportation impacts. All these agencies rely heavily on accurate mapping which can be generated as a benefitting byproduct of this project.

Activities and Milestones

Activity 1: Historical Survey Records Research

Activity Budget: \$40,000

Activity Description:

To assure that all historical record survey evidence is considered, the surveyor will compile records from available sources and list key records on a preliminary statement of evidence. This research will allow the surveyor to make preliminary conclusions about what the field crew should be searching for in terms of record monuments or evidence. The surveyor will prepare a draft Statement of Evidence compiling the chronological history of record evidence pertaining to each corner. Those drafts will be reviewed by the County Surveyor.

Activity 2: Field Evidence/Monument Search and Final Monumentation

Activity Budget: \$80,000

Activity Description:

The contract surveying company will conduct field reconnaissance for all known historic corners and collect all necessary field feature calls and occupational evidence to allow for analysis and determination of narrow corner search areas. The goal in all cases will be to determine the location of the original GLO corner so as to preserve long standing title lines. A thorough analysis of all field and record evidence will be made and narrowed searches made prior to final corner determinations. Any complex determinations will be discussed with the County Surveyor before final decisions are made.

Activity 3: Corner Documentation

Activity Budget: \$40,000

Activity Description:

A Certificate of Location of Government Corner shall be prepared and filed for each uncertified PLSS corner recovered and/or monumented according to Minnesota Statues 381.12. This certificate shall be a complete document relating to the location, monumentation, perpetuation and history of a corner. The certificates will be reviewed by the County Surveyor and recorded in the Cass County Recorder's Office. A Certificate of Survey showing the location of all PLS corners and the dimensions of all sections will be created and also recorded in the land records.

Long-Term Implementation and Funding

Section corner monuments will be set or found and marked up with signed witness trees for easy field identification by landowners, foresters and resource managers. Section corner certificates will be recorded in the County land records documenting the evidence and location of PLS corner monuments which assures common public use and preservation of the monuments. A complete monumentation map will be created and recorded in land records for use by agencies and surveyors. Future parcel mapping can be improved to act as an aid in resource management and land use management.
