The Ranier City Park is a 2.7 acre area in the heart of the Ranier historic town center. The park was built 50-60 years ago in a beautiful tree covered area that is maintained by the city. The park is heavily used in the summer by regional residents and tourists. It has an existing basketball court, playground area, picnic pavilions, disc golf course, horseshoe pits and an open treed area. There is an intermittent creek drainage swale with pedestrian bridge crossings. There is a gravel parking area in addition to street parking. Most of the park amenities are not necessarily wheel chair friendly. The basketball court is in need of resurfacing and improvements.

What is your proposed solution to the problem or opportunity discussed above? Introduce us to the work you are seeking funding to do. You will be asked to expand on this proposed solution in Activities & Milestones.

The Proposal is to improve the existing park amenities. Due to the current lack of accessibility, ADA compliant concrete walks from the parking area to each of the amenities are proposed. The currently graveled parking area will be paved and marked for ADA accessibility. Additional street side parking will have defined ADA parking spaces. The basketball court will be resurfaced and refenced. Proper drainage through the intermittent creek will be improved. The pedestrian walking bridges will be improved and connected to concrete walks.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

The outcome of this project is to have an improved city park area that is compliant with ADA accessibility standards for all to use for recreation. Families living in the area and tourists that visit Ranier, Rainy Lake and the Voyageur's National park will have an improved area for outdoor recreation.
