The Refuge has prioritized windows at the southern edge of Bloomington Education and Visitor Center which receive the highest number of bird strikes for installation of Feather Friendly film. The award would go towards installation of the film on these windows to reduce bird strikes. The refuge would also independently provide interpretive materials which would explain the purpose of the film to the 25,000 visitors that visit the refuge. This provides an excellent outreach opportunity for bird-strike reduction to the public.

Installation of Feather Friendly window markers to use on exterior windows, which would preserve the architectural character of the building, yet still allow visitors to see out windows and still provide for bird strike reduction.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

For many years the refuge documented similar bird strike issues at the secondary visitor contact point, Rapids Lake Education and Visitor Center (RLEVC). Staff spent many years collecting information on bird collisions at the facility, as well as consultation with an independent architectural firm to identify the primary contributing features of the facility that caused such high numbers of bird collisions. The RLEVC experience an elimination of bird strikes and expect similar results at the Bloomington location.
