Project Summary: The Jones Lake Restoration project will provide critical local and regional water quality and flood protection, habitat preservation, and recreational opportunities for the City of New Brighton.

Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

Intense rainfall in the summer of 2011 led to severe flooding in northern Minneapolis, with the Cities of New Brighton, St. Anthony, and Roseville, among the communities most affected. These communities include those identified by the MPCA as Environmental Justice Areas of Concern (EJAC). EJAC areas include areas in which at least 40% of people reported income less than 185% of the federal poverty, and/or communities comprised of 50% or more people of color. Additionally, 36% of residents in New Brighton are over 55, and 20% are under 17, which provides a unique opportunity to serve these communities with high quality natural resources. The City of New Brighton has identified Jones Lake as a known flood damage problem location as part of their Basic Water Management Project for the Ramsey County Ditches 2, 3, and 5 public drainage systems. The Jones Lake Restoration project aims to address the severe flooding by providing necessary flood storage to preserve the lake, as well as preserve wildlife habitat, improve water quality and recreational access for future generations.

The City of New Brighton seeks funding from this LCCMR grant to acquire land easements and/or fee title from 6 parcels to address the flooding concern, improve wildlife habitat, water quality and create accessible recreational opportunities. This application is being procured at the beginning of the multi-phase project. Future phases of this project will include removing accumulated sediment, increasing the dead storage of the pond and lowering the normal water level (NWL) which will provide critical flood storage. The project also includes modifications to the existing outlet control structure, and to the ditch RCD 5 which discharges into the Jones Lake. Lastly, the lake lacks existing infrastructure and access for recreational opportunities like walking and biking. New Brighton is home to many communities of color and communities reporting income less than 185% of the federal poverty level. The last phase of the project includes the implementation of walking trails, park areas, cycle tracks and fishing piers in order to provide access for all residents.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

This project will provide critical flood storage and protection that will mitigate downstream flooding of local streets, businesses and residential areas including MPCA identified Environmental Justice Areas of Concern. This project will also benefit Long Lake and Rice Creek water quality, which are impaired waters downstream of Jones Lake. It will restore the existing resource by improving water quality and habitat via sediment reduction and enhance the quality of the region through the introduction of new parks, trails, and green spaces surrounding the lake.

The Jones Lakes Restoration Project is a long-term project with multiple phases that will be completed over the next few years. Funding for the larger project will come from eligible grants received, State and Federal allocations, Rice Creek Watershed District, and from the City of New Brighton. Once this project is completed, the City of New Brighton will be responsible for maintaining the lake, the outlet structure and the surrounding recreational areas.

Easement (Other) Acquisition

1. Describe the selection process for identifying and including proposed parcels on the parcel list, including an explanation of the criteria and decision-making process used to rank and prioritize parcels.

Parcels were identified based on the proximity of the existing Jones Lake, existing county ditches, and potential for future restoration and recreation efforts. Four of the nine parcels identified on the parcel map are already owned by the City of New Brighton and will not require acquisition. Parcels were also identified based on the proximity to Ramsey County Ditch 2, leaving the lake and Ramsey County Ditch 5 which discharges to the lake. Additionally, future improvements requiring land, such as flood storage, park areas, fishing piers, walking trails and bike trails were considered when identifying the proposed parcels. Acquisition of these parcels will provide high quality natural resources that provide multiple habitat, water quality, flood mitigation and recreational benefits.

The City of New Brighton Comprehensive Plan including the Surface Water Management plan will be implemented.
