# **Narrative**

#### Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

The number of East African immigrants in St. Cloud and the surrounding areas Saint John's Outdoor U serves has grown exponentially in recent decades. Since its formation in 1997, Saint John's Outdoor U has built a strong partnership with St. Cloud Independent School District (ISD) 742 and the surrounding districts to deliver environmental education field trip experiences that help to meet state science standards. Of the approximately 3000 PreK-12 students we serve annually, roughly 15 percent are recent African immigrants or come from a household of recent African immigrants. Currently no Saint John's Outdoor U professional or student staff comes from an East African background, nor are they fluent in any languages commonly spoken in the region. This is problematic for the following reasons:

- Saint John's Outdoor U staff may not be appropriately adapting curriculum delivery to meet the cultural norms of others.
- Saint John's Outdoor U staff struggle with communication and connection barriers.
- Not seeing a person of East African descent on Saint John's Outdoor U staff perpetuates the belief that outdoor spaces and environmental science fields are not for underrepresented groups. The time has come to break through these barriers to empower new environmental leaders and build community.

Saint John's Outdoor U will collaborate with CAIRO to:

- 1. Assess and improve the effectiveness of PreK-12 environmental education programming to serve a growing population of East African immigrants and refugees in the Stearns County area.

  CAIRO will assist in recruiting a multi-lingual Multicultural Specialist to review, assess and assist in the delivery of Saint John's Outdoor U environmental education programs. This will ensure that programs are relevant to East African audiences and improve cultural agility of current professional staff.
- 2. Pilot an environmental education fellowship program to empower recent graduate(s) of CAIRO's existing CONNECT program with the skills, experience, and network to kickstart a career in environmental education. CAIRO will assist in recruiting and supporting an annual Environmental Education Fellow. The position features advanced development of environmental interpretation skills, teaching techniques, and natural history knowledge through handson training and participation in seminars, workshops and continuing education. Opportunities for collaboration with College of Saint Benedict and Saint John's University professors as well professionals working in multiple fields will be provided.
- 3. Develop and facilitate culturally relevant monthly outdoor recreation/education community programs. CAIRO will assist in recruiting East African community members for outdoor education and recreation opportunities.

# What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

Multicultural specialist and external environmental education consultant will produce written assessment and recommendations to improve Saint John's Outdoor University environmental education field trip curriculum serving over 450 East African K, 2, and 3rd grade students annually (1800 total).

Four East African Environmental Education Fellows will gain the skills, knowledge, experience, and professional network to secure future work in this field and serve as trailblazer environmental educators with unbelievable potential to inspire an entire community to connect with and care for Minnesota's natural resources.

720 East African community members participate in fun and safe exploration of Minnesota outdoor education/recreation opportunities.

This will ensure that our field trips are relevant to East African audiences and improves the cultural agility of current professional staff and student naturalists.
