## Narrative

#### Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

There is an unmet demand for outdoor programs designed for young children, particularly underprivileged and at-risk youth ages 8-11. While outdoor activities offer significant benefits, limited access to such programs prevents many of these children from connecting with nature, developing outdoor skills, and learning to be good stewards of the environment. Funding constraints make it challenging for nonprofits to expand such programs.

When young people miss the chance to explore Minnesota's incredible natural resources—its lands and waters—they are less likely to develop a lifelong commitment to protecting the environment. The saying, "We don't inherit the land from our ancestors; we borrow it from our children," holds true only if we teach children to engage with and appreciate the natural world. To ensure future generations value and care for the environment, we must give them early opportunities to experience and enjoy it.

Reel Hope: Breaking Outdoor Recreation Barriers for Youth aims to bridge this gap. Not all youth have access to Minnesota's natural resources, but they all deserve the chance. We are committed to making that access a reality by expanding our Reel Hope programming, currently funded for ages 11-17, to encompass youth ages 8-17.

To address the lack of outdoor programs for at-risk youth, Reel Hope will implement a structured, multi-phase solution that expands access, deepens engagement, and builds a clear progression for participation.

First, we will develop new and deepen current resources, expanding our pipeline by collaborating with organizations that already serve at-risk youth. These partnerships will help bring children into programs while providing outdoor learning experiences not currently offered. By working together, we can extend our reach and introduce more young people to Minnesota's natural resources.

Next, we will establish a step-by-step program progression tailored to different age groups and skill levels. Youth will begin with hands-on activities like rod, reel, and tackle box rebuilding events (replacing lead tackle with eco-friendly items), followed by fishing experiences. Refurbished equipment will be used by youth in Phases 2 and 3, where they will work with skilled anglers in shore fishing and progress to one-day guided lake fishing.

To ensure more children benefit from these opportunities, we will expand our staffing. A dedicated staff member will oversee event and program quality. This role will ensure that each stage of the program is thoughtfully designed, effectively implemented, and impactful for the youth we serve,

# What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

This project will bring in youth ages 8-11 and integrate youth ages 8–17 into a cohesive program, maximizing impact through streamlined Fishing For Life initiatives. By engaging underserved youth, we provide a pathway from to the outdoors, fostering confidence, life skills, and lasting mentorship connections. Hands-on experiences in nature will instill a deeper appreciation for Minnesota's natural resources, promoting conservation, preservation, and responsible stewardship. As participants progress through the program, they will develop the knowledge and values necessary to protect and enhance the state's lands and waters for future generations.

## Activities and Milestones

## Activity 1: Phase 1—Build: Restoring and Distributing Fishing Gear

Activity Budget: \$32,190

#### **Activity Description:**

Objective: Establish a foundation for youth development by building relationships, fostering teamwork, and engaging participants in hands-on conservation efforts.

Tasks & Methods: Youth will participate in structured team-building activities, work alongside mentors to refurbish donated fishing equipment, and learn about conservation, particularly reducing lead-based tackle. These activities will be delivered through a minimum of 6 one-day events, with positive adult mentors guiding participants in problem-solving, communication, and collaboration. Conservation experts will provide education on sustainable fishing practices.

Outcomes: Participants will develop teamwork and leadership skills while gaining hands-on experience in fishing equipment restoration. Each youth participant will using the rod/reel they themselves refurbish for Phases 2 & 3 of the program. Youth will experience a sense of achievement, build confidence, and establish positive relationships with mentors. Additionally, the program will supply refurbished fishing gear to other youth programs, ensuring sustainability and continued impact.

## Activity 2: Phase 2 — Explore: Shore, Dock, or Pier Fishing on Minnesota Lakes

Activity Budget: \$68,570

#### **Activity Description:**

Objective: Provide youth with immersive fishing experiences that enhance skill development, promote environmental awareness, and strengthen personal and social connections while continuing positive relationships with mentors.

Tasks & Methods: Youth will participate in 4-6 shore, dock, or pier fishing outings on accessible Minnesota lakes. Mentors will provide hands-on training with fishing techniques, safety protocols, and ethical angling practices. Youth will learn about local fish species (panfish), using a simple hook with a lead-free weight and a bobber, catch-and-release techniques, and the environmental impact of lead-free tackle. They will learn about how to bait hooks, how to cast with their rod/reel, how to read the water and where fish are at the time of the year, how to remove a fish so that it can survive and continue to thrive after release. Other topics addressed will include invasive species, the negative impact of littering, and pitching in to help cleanup local lakes. Teamwork, patience, and resilience will be demonstrated through guided discussions and peer interactions.

Outcomes: Participants will develop foundational fishing skills and confidence in their abilities. Youth will establish meaningful relationships with social connects, gaining awareness of responsible outdoor recreations on Minnesota lands and waters.

## Activity 3: Phase 3 — Transform: Reel Hope Youth Fishing Events on Minnesota Lakes

#### Activity Budget: \$48,240

#### **Activity Description:**

Objective: Offer an intensive fishing and outdoor experience in a boat with a guide that reinforces leadership, personal growth, and advanced skill development.

Tasks & Methods: Participants selected from earlier phases will attend a one-day immersive fishing experience on a boat. Hands-on training in boat fishing and sustainable fishing methods will be provided. Youth will be instructed about multiple fish species, lake ecology, drop-offs, weed beds, and other structures that affect fishing. There will be introduction to fish-finding equipment and motors, as well as various casting baits. Demonstrated examples of outdoor leadership and environmental stewardship will be displayed by the program coordinator and volunteers.

Outcomes: Participants will refine their fishing skills while developing leadership abilities, teamwork, and problemsolving skills. This experience is designed to build self-confidence and foster a deeper appreciation for nature. Through mentorship, participants will form meaningful connections and gain a sense of personal achievement. Mentors will also emphasize the importance of environmental stewardship, teaching responsible fishing practices that help protect lakes and fisheries.

Fishing For Life's Reel Hope program will provide at-risk youth (ages 8–17) with meaningful outdoor experiences, fostering connections to Minnesota's lands and waters. Program results will be sustained through continued mentorship, progressive skill-building opportunities, and environmental stewardship education. During and after project completion, ongoing efforts will be funded through a combination of grants, private donations from individuals, businesses, and foundations, and broad community support. This diversified funding approach ensures the long-term viability of the program, allowing more youth to develop a lifelong appreciation for nature while reinforcing conservation and preservation efforts across the state.

#### **Organization Description:**

Founded in 2004, Fishing For Life has dedicated over two decades to serving youth, families, veterans, and communities through eight plus fishing and outdoor programs, reaching over 63,000 youth and adults since its inception. Intentionally designed fishing and outdoor programs serve as avenues for building relationships with various groups across the state, including at-risk youth, families, veterans, and communities in Minnesota and throughout the Midwest.

Through its outreach efforts, Fishing For Life has positively impacted thousands of youth, veterans and families over the years, and it remains committed to expanding its reach and making a lasting difference in the community. In 2024 alone, Fishing For Life leveraged its robust programs to orchestrate over 175 community events and served 284 youth campers and 465 military veterans and active duty personell. We received donations of 1,410 rods/reels and 270 tackle boxes for our Reel 'Em In program, where we refurbish fishing equipment and work to remove lead tackle with more eco-eco-friendly items. Our events are made possible by the dedication of 830 volunteers, collectively contributing over 7,250 hours. Since our establishment, we've proudly extended the joy of recreational fishing and outdoor experiences to a vast community.
