Project Summary: Lake Byllesby Campground improvements will include construction of a new bathhouse and severe weather shelter building to improve accessibility, erosion concerns, climate resiliency and services.

Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

Lake Byllesby Regional Park is a 1,300-acre reservoir of the Cannon River. The Regional Park offers diverse outdoor recreation opportunities and direct access to Lake Byllesby. One of the many high-demand outdoor recreation destinations is the Lake Byllesby Campground located in the eastern portion of Lake Byllesby Regional Park. Annually, there's approximately 250,000 visitors a year with more than 9,000 being overnight campers for each camping season. This proposal responds to priorities identified in the Lake Byllesby Regional Park Long-Range Plan (2018) that seek to improve the camping experience at Lake Byllesby while balancing preservation of the Regional Park's natural areas. The existing campground building is more than 30 years old and is built in a low-lying area that is prone to flooding. During large rainfall events, drainage from the roof falls directly around the foundation of the building; increasing the rate at which the stormwater accumulates, causing the building to sink into the ground. The facility is also currently undersized for the campground's needs, improvements could address accessibility and the lack of a storm shelter. This concept aligns with LCCMR's strategic goals surrounding long-term ecological benefits for fish, wildlife, and enhancing recreation for people.

Increased visitor counts and the associated maintenance needed to keep up with increased demand are the drivers for the proposed campground bath and shelter building that will serve park visitors, campers, and staff. The proposal seeks funding to construct a new facility, which will include a 2,500 square foot Bathhouse building that has space for six single-occupant bathrooms with showers, three individual shower stalls, and mechanical and electrical rooms. These improvements are essential for enhancing visitor experience and elevating Lake Byllesby's recreational value. The construction of the proposed facility will allow park staff to better serve park visitors and campers and provide enhanced safety and accessibility features, such as having the building designed to serve as a severe weather shelter. By prioritizing this project, Dakota County shows its commitment to high-quality recreational services and natural resource access. These improvements will ensure the area's resilience, will benefit future generations of park visitors, and will maintain Lake Byllesby as a premier destination for outdoor enthusiasts, campers, and day users.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

This project will meet the outcomes of LCCMR's constitutional purpose through responsible land stewardship and the preservation of the Regional Park's natural environment. Replacement of the proposed facility will move it out of a flood prone area, improve stormwater management in the vicinity, and ensure sanitary services are safely addressed. Improvements will continue to meet the needs of the users who frequent the area and encourage appreciation of Minnesota's natural resources, which will in turn contribute to the long-term ecological health of the area, benefiting fish, wildlife, and people.

Activities and Milestones

Activity 1: Design and Approvals

Activity Budget: \$100,000

Activity Description:

The objective of this activity is to complete final design of the project, obtain necessary approvals, and advertise the bid for the Lake Byllesby Regional Park Campground Building. Tasks include completing design review with the Department of Administration and SHPO, approving final designs, and going out to bid for the project. The design process will be led by Dakota County and include design development through construction documents and incorporate community feedback, building on the existing efforts of Dakota County. County Park staff will work with design consultants to finalize design plans and prepare all necessary documentation for reviews and going to bid. The design will comply with local and state regulations, be ADA compliant, and will meet the State's energy code. A soil report and geotechnical reports will support the final engineering design. Park staff will oversee the advertising of the bid and move the project into the pre-construction phase. The design phase of this project will incorporate feedback from community and stakeholder engagement and the expertise of park staff into final designs.

Activity 2: Bidding and Pre-Construction

Activity Budget: \$100,000

Activity Description:

Once the design and construction documents are finalized, the second main activity of this project will address the bidding process and contractor preparation for construction. Tasks include contractor selection, acquiring all necessary permits and funding, and construction preparation.

County Park staff will oversee the selection of contractors during the bidding process and help as agreed upon with construction administration and oversight. Contractors will complete pre-construction tasks including site preparation.

Activity 3: Construction

Activity Budget: \$2,900,000

Activity Description:

This activity brings the proposed improvements through construction to project completion. Tasks include construction, construction oversight and administration, and project close-out.

Construction of the Lake Byllesby Regional Park Campground Building will involve installation of necessary utility infrastructure to support the building and site design. Additional exterior improvements related to the building will require reestablishing concrete pathways, landscaping and native plantings.

The utility improvements aim to ensure the proposed campground building will have reliable and efficient sanitary and water services. A new septic system will be installed with a larger drain field and a new water main will also be installed at the building. This will guarantee a fully functional sanitary system that meets the needs of higher visitor counts and reduces environmental impact of the building. County Park staff will help as agreed upon with construction administration and oversight. Contractors will complete construction tasks.

The long-term implementation of the project will be guided through strategic actions outlined in the 2018 Lake Byllesby Park Plan. Additional capital improvements identified in the park plan will be funded through the annual capital improvement budgeting process. Long term maintenance and management of these improvements will be performed by the Dakota County Parks and Facilities Department as part of the County's ongoing management program. These activities are funded by tax levy, external grant funding, and are supported through regional parks operations and maintenance funding.
