Project Summary: The Carey Lake Campground Construction Phase II completes site development for the City's new, sole campground located within the regional park.

Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

In the 2023, the City hired Barr Engineering to evaluate how the City moves the park system forward into a new generation of park development recognizing recreation trends and financial constraints. Through this comprehensive master planning process, the city learned that Carey Lake, as a regional park, has the greatest capacity to both serve local citizens and draw visitors. However, the park's existing facilities are aging and limited to a fishing dock, beach, pavilion and ski trails, and the park's potential is unrealized.

Carey Lake park contains 1,219 acres and boasts unique natural features. With the 139-acre Carey Lake, Carey Creek, forests, and wetlands, the park conserves and preserves the Eco-system as a carbon-reducing, sustainable landscape. But use of this mecca is limited. In the 2023 statistically valid Parks Public Input Survey respondents expressed a desire for a campground at Carey Lake Park. In response to the question, "How specifically do you recreate (or would you like to recreate) at Carey Lake?" ~40% of respondents chose "RV camping with amenities" as one of their top desires. The City began construction in 2024 but needs financial assistance to fulfill this charge.

The City of Hibbing began construction of Hibbing's singular, long-awaited 40-site campground at Carey Lake Park in 2024. The City awarded bids for Phase I of the project and the site was cleared and grubbed. In 2025, well drilling and the sub-surface sewage treatment design and build will be completed.

The campground will include ADA sites, electric hook-ups at each site, water, a dump station and wi-fi. Ultimately, the project will include a bathhouse with adjoining community room and a maintenance shed. With this application the City is requesting funds to help complete Phase II construction of the project: final site development and service connections for fiber and electrical.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

Goal 5: 5.2 of the ENRTF strategic plan includes the assessment of "physical spaces for their accessibility and effectiveness and/or implement changes to adapt and retrofit them to welcome more people." In the 2023 Parks Master Plan community engagement sessions, the City learned of the community's desire for a campground at Carey Lake among other improvements. The construction of the new campground meets Goal 5: 5.8, development of outdoor recreation facilities and infrastructure... that create new natural resources-based experiences and 5.9, expanding "... parks, or natural areas" to "improve accessibility... for all Minnesotans."

Long-Term Implementation and Funding

Carey Lake park currently sees 150 users a day (on average). Owned and maintained by the City of Hibbing, the city will continue to fund operations through the annual city budget. Additionally, community organizations (e.g., Range Nordic Gliders) are committed to assisting with maintenance through volunteering. The city has a master development plan for the park, which includes a proposed shower/bath house with attached community room, ADA bog walk trail, a connector trail to Redhead Mountain Bike Park, and a storage/maintenance space. The city plans to fund these projects through a mixture of public and private dollars.

As Director of City Services, project manager Nick Arola manages and oversees the operation of multiple city-owned properties including the Hibbing Memorial Building (Hockey Arena & Community Center), City Hall, Greyhound Bus Museum, 33 parks totaling approximately 1,890 acres, the Hibbing Municipal Golf Course, and various pavilions & sports complexes. With a departmental budget of roughly three million dollars, Arola is responsible for capital improvements and project management to existing and future facilities.

Arola is well qualified to manage this project. In 2024, Arola oversaw the completion of a \$2.5 million construction

project at the Mine View Park, a \$1.7 million dollar renovation of Hibbing City Hall, and Phase I of the Carey Lake Campground project. As part of the City development team, Arola is co-leading the current \$29.6 million public safety building project and assisting with a \$7-\$10 million industrial building construction project.

On the finance side, Arola is aided by a City finance team of 6 FTE who manage an annual municipal budget of approximately \$20 million. One FTE is designated to manage state and federal grants, and the team regularly manages various state and federal funds annually including local government aid, MnDEED grants, MnDNR grants, local area housing aid, emergency medical services aid, FEMA grants, and the like. The City utilizes software to track revenue and expenses and submit regular reports to the various agencies as requested.

With a robust background in project and fiscal management, backed by the development and finance teams of the City, Arola is well-prepared to manage Phase II of the Carey Lake Campground project.

The City of Hibbing is a Statutory Plan A City with a population of 16,214 located on the Mesabi Iron Range in northeastern Minnesota. We are mission driven to improve the quality of life for all residents through the delivery of quality and sustainable services by leveraging resources, opportunities, and our strengths.

One of our best resources and opportunities is our 1,890 acre park system, of which Carey Lake is a crowned jewel. Through our 2023 Park Master Planning process, the potential of Carey Lake Park as a regional destination was unveiled, and our residents expressed desire for rehab and development of Carey Lake.

Recognizing that outdoor recreation is key in resident health, quality of life and an economic driver, the city is working strategically to fulfill this request and meet our vision.
