Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

Trails maintenance at Lake Brophy Park has been challenging due to its exposed nature and frequent use. The trails are not covered by trees or tree canopy. Although the single track trails dry quickly because of the exposed nature. The trails are close to Alexandria, connected by the Central Lakes Trail and are ridden even when the trails are muddy. The untimely use increases erosion. The challenge is exaggerated for the skills course with increased slopes. The Bomber trail was rebuilt with our last successful grant from LCCMR. However, the table tops could be tuned to improve the rideability of the trails. There are very few rock gardens in the Lake Brophy Park single track trails. Our Minnesota Cycling Association team predominantly trains and rides at the Lake Brophy single track trail system. Strategically positioned rock gardens will improve our rider's skills and help them with riding other race courses with more rocks and roots.

The initial funding is through Douglas County and Douglas County Parks. They are also the fiscal agents.

Maintenance has been co-operative between Big Ole Bike Club and Douglas County Parks. According to the trail builder that created the skills trails, we have done a nice job with trail maintenance. But Trail Armor MTB, trailarmormtb.com, offers protection for sloped trails, reducing maintenance needs and preserving the original design. Trail Armoring of the Skills Area will decrease erosion, ruts and maintenance. Trail Armor is a commercial mat that covers the trail tread of sloped surfaces. It would be professionally installed with hardware to anchor it. The surface rides similarly to dirt. Over time, it becomes enmeshed with the dirt trail surface. It repels water and resists ruts. After trail preparation, it would be professionally installed. The skills park develop essential skills for mountain biking, including balance, neuromotor, muscle training, cardiovascular capacity, and attentiveness or situational awareness.

Tune and improve the table top features on the Bomber trail at Lake Brophy Park.

Strategically positioned rock gardens as option to the primary trail will improve our rider's skills and help them with riding other race courses with more rocks and roots. Improved skills make for safer and more efficient riders.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

We have developed single track trails at Lake Brophy Park and Kensington Rune Stone Park protecting, conserving, preserving and enhancing the states natural resources and have seen increased park usage.

Several team member's parents have purchased bikes and now ride with their kids on existing trails in the two parks. Big Ole Bike Club members along with the county park's employees, using a groomer purchased by Douglas County Parks to groom trails for winter biking or what is known as "fat tire" biking. Increasing protection, conservation, preservation of the state's natural resources by improving visibility and engagement with the community.

Activities and Milestones

Activity 1: Lake Brophy Park Trail Armoring of the Skills Area

Activity Budget: \$50,000

Activity Description:

Trail maintenance of the skills trails at Lake Brophy Parks' sloped trails can be challenging particularly during last years' wet summer. Trail Armoring of the Skills Area will decrease erosion, ruts and maintenance. Trail Armor is a commercial mat that covers the trail tread of sloped surfaces. It would be professionally installed with hardware to anchor it. The surface rides similarly to dirt. Over time, it becomes enmeshed with the dirt trail surface. It repels water and resists ruts. After trail preparation, it would be professionally installed. The skills park develop essential skills for mountain biking, including balance, neuromotor, muscle training, cardiovascular capacity, and attentiveness or situational awareness. These skills help reduce injuries during mountain biking and promote community health.

Trail maintenance has been co-operative between Douglas County Parks and Big Ole Bike Club. Rune Stone Off-Road Cyclists have had regular volunteer days to repair erosion and cap berms with clay based soil provided by Douglas County Parks to improve riding and resist degradation.

The skills park develop essential skills for mountain biking, including balance, neuromotor, muscle training, cardiovascular capacity, and attentiveness or situational awareness. These skills help reduce injuries during mountain biking and promote community health.

Activity 2: Improve the features of the Lake Brophy Bomber Trail

Activity Budget: \$10,000

Activity Description:

Some riders have difficulty timing the tabletop features of the Bomber Trail at Lake Brophy Park. The second activity would be to remodel the tabletops so that more riders could enjoy them. The revised trail should be safer.

Activity 3: Build and create rock gardens at Lake Brophy Park Single Track Trail System

Activity Budget: \$10,000

Activity Description:

The high school and middle school Minnesota Cycling Association Team ride and train at Lake Brophy Park most of the time. While it has many advantages: proximity to Alexandria, connection by Central Lakes Trail, fun flowy trails with substantial elevation change (for the Midwest). There are not any rock gardens, so our riders aren't accustomed to

them. The third activity is build and create rock gardens that can be bypassed from the primary trail. Those who choose, can ride them, others can elect not to ride don't have to. These skills help reduce injuries during mountain biking and promote community health.

Long-Term Implementation and Funding

Trails will be maintained by the Douglas County Parks (DCP) and Big Ole Bike Club (BOBC). DCP have dedicated employees for trail maintenance and development. BOBC, together with our Cycling League team has volunteer days for trail building and maintenance for existing trails.

An example of the partnership between Douglas County Parks and Rune Stone Off-Road Cyclists may be grooming the single track trails for fat biking. One of the employees has trained 8 of us to date to groom the trails with machinery purchased for trail grooming.

Provide description of the project manager's qualifications to manage the proposed project.

The first project is trail armor installation on the skills course to reduce erosion and subsequent maintenance.. The Bomber trail will be improved so the technical features ride more appropriate to the incline of the trails. Rock gardens will be added strategically to the trail system. All projects will be cooperatively managed by Brad Bonk, Douglas County Parks Supervisor and Jeff Brand, Volunteer Trail Builder. The project will be competitively bid per Douglas County requirements for a project of this size. Together Brad Bonk and Jeff Brand have successfully overseen professional single track trail building at Lake Brophy Park, in spring of 2019 and an addition of skills area, downhill trail and trail revision. Together, they supervised and built with volunteers, 8 miles of single track trails at Kensington Rune Stone Park (KRP) with signage, marking, and maintenance of both Douglas County Parks with single track trails.

Brad Bonk has a long history as a parks supervisor. In Douglas County, he as managed the development of two county parks. At Lake Brophy Park, the progress included the aforementioned single track professional build, a very large playground, parking lot, a beach and a visitor center. At KRP, development included road and parking lot rerouting, the above-mentioned 8 miles of single track trails and a visitor center.

Jeff Brand, MD, a Sports Medicine Fellowship trained Orthopaedist, has had leadership experience in medicine and with trail development, maintenance and trail improvement. Together with Brad, the aforementioned single track trails at Lake Brophy and KRP were developed.

Organization: Big Ole Bike Club

Organization Description:

The strength of Big Ole Bike Club (BOBC) is its membership. It is a volunteer organization with no overhead. The infrastructure- the 501(c)3 organization, website, digital communication, digital invitations for meetings-were all created by active board members. Club members also groom the winter bike trails. Big Ole Bike Club members have served as team manager, head coach, assistant head coach, and ride leaders for the Alexandria Mountaineers. With volunteer trail workers, BOBC members worked over 700 hours to build and develop professionally designed single track trails at Kensington Rune Stone Park (KRP).

Brad Bonk, Douglas County Parks Superintendent has been a great partner in our efforts to build and develop single track trails in two county parks. Douglas County Parks (DCP) funded \$10,000 for a professional trail design at KRP. They purchased a trail groomer used for winter biking. Together BOBC and DCP groom the trails at KRP for winter biking. Also, DCP has purchased a utility bike with BOBC contributing a portion. The bike will be used for trail maintenance, a task shared between BOBC and DCP. This partnership has been effective in managing the over 15 miles of trails in two parks.
