Project Summary: The proposed project will foster environmental stewardship and conservation across Minnesota by significantly expanding hands-on, environmental education through mobile live eagle experiences and removing barriers to youth participation.

There is a need to educate, inspire, and empower more of Minnesota's young people to become environmental stewards and advocates. This proposal, Taking Eagle Education & Experiences Across Minnesota (Project TEAM), fosters environmental stewardship statewide by removing existing barriers and increasing opportunities for students to have formative, environmental experiences. In the face of increasing environmental degradation and decreasing biodiversity, many young people are experiencing a sense of anxiety and hopelessness. In MN, there are 130 different native species identified as endangered. Project TEAM leverages increased attention on the Bald Eagle (since officially becoming the national bird in 2024) to share a powerful conservation success story, educating and inspiring 17,000 Minnesotans over two years.

Many school districts and libraries, particularly in rural and low-income areas, lack the financial capacity to provide these formative experiences. This proposal will dramatically increase opportunities for Minnesotans, especially young people, to have formative experiences that lay the groundwork for lifelong environmental stewardship. NEC education staff will strategically reach out to these areas, offer scholarship support for programming, and tailor education to meet the needs of their students. This work will help strengthen an ethic of environmental stewardship among Minnesota's younger generations for years to come.

Project TEAM significantly expands the NEC's successful mobile eagle experience programs, while also reducing financial barriers for school districts and community partners to participate regardless of budget constraints. Last year, NEC's mobile live eagle programs reached more than 5,000 Minnesotans across nearly 50 separate programs. Through Project TEAM, NEC will reach 17,000 (including 7,700 youth) Minnesotans over two years. NEC will do this by proactively engaging low-income schools, increasing capacity to deliver more outreach programs throughout the year, and reducing financial barriers for school and community partner participation. Critically, this project creates a scholarship fund so low-income districts and community partners have equal access to the transformative experience of live eagle encounters.

The Bald Eagle is the greatest conservation success story in American history. Through sustained advocacy and a commitment to stewardship, policies and practices were changed to protect Bald Eagle populations. There is an opportunity to share this empowering story through hands-on, direct experiences, (which are effective ways to inspire and cultivate a lifelong stewardship ethic), while also exposing young people to environmental education careers. Now is an ideal time for this expansion, as the Bald Eagle was officially named the national bird in 2024.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

Project TEAM cultivates the next generation of environmental stewards in Minnesota by expanding NEC's successful mobile eagle encounter program and by reducing financial barriers to participation.

Proactively engage at least 40 underserved school districts or communities (with no existing relationship with the NEC) about the mobile eagle program and scholarship fund;

Educate and inspire 7,700 Minnesota students (17,000 total individuals) through over 120 mobile eagle education and encounter programs over two years;

At least 50% of new schools or communities will indicate interest in additional mobile programs, and assist NEC with locating local sponsors for continued outreach.

Activities and Milestones

Activity 1: Taking Eagle Education and Experiences Across Minnesota (Year 1)

Activity Budget: \$136,725

Activity Description:

With recent increased attention on the Bald Eagle, and a need to share and empower young people through a conservation success story, the NEC will increase organizational capacity and reduce financial barriers through a new scholarship fund.

NEC staff will compile a list of priority districts and communities by reviewing publicly available income/poverty data. This will include particular attention to Native Nations, including the four Dakota Nations and the seven Anishinaabe (Chippewa/Ojibwe) Nations. NEC staff will communicate with priority sites, sharing information about the scholarship fund and inviting them to participate.

NEC staff speak directly with the school or host site, learning how to adapt programs to meet the needs of the students (and families, if applicable) that they serve. Programs will include a brief description of environmental education career pathways, with NEC professional education staff serving as an example.

Mobile programs will educate young people on the conservation success of the Bald Eagle, current habitat threats, and ways to be environmental stewards, all while connecting them directly to live eagles and raptors and fostering a deep stewardship ethic.

Finally, NEC staff will develop a community sponsor program in Year 2, sustaining the program's access to low-income partners.

Activity 2: Taking Eagle Education and Experiences Across Minnesota (Year 2)

Activity Budget: \$139,275

Activity Description:

NEC staff will continue to build a list of priority districts and communities by reviewing publicly available income/poverty data, expanding on the work in 2026. This will include particular attention to Native Nations, including the four Dakota Nations and the seven Anishinaabe (Chippewa/Ojibwe) Nations. NEC staff will communicate with priority sites, sharing information about the scholarship fund and inviting them to participate.

NEC staff speak directly with the school or host site, learning how to adapt programs to meet the needs of the students (and families, if applicable) that they serve. Programs will include a brief description of environmental education career pathways, with NEC professional education staff serving as an example.

Mobile programs will educate young people on the conservation success of the Bald Eagle, current threats, and ways to be environmental stewards, all while connecting them directly to live eagles and raptors and fostering a deep stewardship ethic.

Concurrently, NEC staff will work to develop partnerships and secure new funders to sustain mobile programming beyond LCCMR funding.

Finally, NEC staff will collect and review all surveys, evaluate and analyze the data to drive future programming. Staff will also compile and submit the final report to LCCMR.

Long-Term Implementation and Funding

Project TEAM is a two-year, catalytic investment to expand the Eagle Center's mobile eagle encounter and education program. As programming impacts more school districts and communities, NEC will identify private funders to help continue scholarships, including launching a 'community sponsorship' program that empowers funders to pay for mobile programs in specific schools, districts, and communities. As more statewide mobile programming occurs, NEC's increased profile will help to identify and secure additional private, philanthropic partnerships to fund expanded mobile programming beyond the project period.

NEC Director of Education Scott Mehus has led the Center's education department for nearly 20 years, including overseeing mobile environmental education programming. He directly manages three full-time avian education specialists and a programs & events manager, while reporting directly to the Executive Director. He will be responsible for the project to meet all objectives, working closely with his staff on implementation.

Last year, under Director Mehus' leadership, the NEC reached more than 5,000 individuals through outreach and engagement programs, and more than 40,000 individuals were served by the NEC's on-site programming. He has overseen enhanced exhibit and on-site programming, as well as directed improvements to the mobile eagle encounter programs. With established relationships with regional schools and partners, as well as a deep network of environmental education professionals, Director Mehus is the ideal leader for this project.

Director Mehus also leads the Golden Eagle Project, which documented the first Golden Eagle nesting in Minnesota nearly twenty years ago. He has continued that annual effort while developing plans to increase and enhance data collection, and has published three peer-reviewed articles on his work during his tenure at the NEC.

Organization: National Eagle Center

Organization Description:

The National Eagle Center, based in rural Wabasha County, is a unique nature center focused on environmental education through direct experiences with live Bald Eagles and other raptors. Our mission is to connect people with eagles in nature, history and culture. Our educational programs cultivate rich natural and cultural understanding and facilitate a lifelong stewardship ethic. We currently care for five permanently injured raptors, who all serve as ambassadors during educational programs. Incorporated as EagleWatch, Inc in 1995, we started as a volunteer-run eagle viewing group in the 1980s and opened as the "Eagle Center" in 1999. Following a successful capital campaign, NEC hopes to grow from a regional to statewide leader in environmental education. Increasing access to and enhancing our mobile environmental education programs, as well as expanding our citizen science projects, helps NEC achieve that strategic goal.

Each year, NEC welcomes tens of thousands of children, adults, and families who explore interactive exhibits, enjoy naturalist-led field trips, and meet our permanently injured Bald Eagle Ambassadors. In FY24, reached nearly 5,000 people by delivering over 45 mobile environmental education programs.
