## Narrative

The Minnesota Forest Zone Trappers Association (MFZTA) is requesting an \$1,050,000 a LCCMR grant for Phase 2 of the development and construction of the Sportsmen's & Sportswomen's Training and Developmental Learning Center (SSTDC) along with all necessary amenities. Phase 1 of this project consisted of completing a master plan and an infrastructure analysis of the site. Phase 2 includes site preparation and grading, construction of site amenities and project design. Site preparation includes clearing/grading, wetlands review, surveying, hazardous materials evaluation, road construction, culverts and parking lots. Site amenities include a construction of a training pond, security fences, archery range, bleachers, bogwalk and overnight camping site development. Phase 2 also includes all project design needed. Total overall cost of Phase 2 is \$1,400,000.

The SSTDC meets LCCMR's constitutional aim of protecting, conserving, preserving, and enhancing Minnesota's air, water, land, fish, wildlife, and other natural resources all in one location. The center will educate and train people from around the State of Minnesota, increasing their knowledge of the outdoors and teaching them skills that will help them cultivate a sustainable lifestyle and maintain a healthy and biodiverse natural environment through hunting, fishing, and other outdoor activities.

The MFTZA is a non-profit 501C3 Corporation operating under the laws of Minnesota. They encompass over seven counties throughout northeastern Minnesota. The primary purpose of the MFTZA will be to achieve the best possible, highest quality outdoor experience. Their work to date to develop this project include meetings with regional, state and federal government officials, educating the general public, holding outdoor programs, regulation enforcement training, support wildlife research and developing relationships with wildlife officials and promoting good sportsmanship and ethic outdoor practices. The MFZTA offers multi-day conventions, annual workshops and numerous training sessions throughout the year that focus on education and environmental stewardship.

The MFTZA has developed satellite programs in which they partner with Delta Waterfowl, MN Deer Hunters Association, Pheasants Forever, Grouse Society, MN Darkhouse and Angling Association, Ducks Unlimited, NRA, National Turkey Association and others to promote outdoor activities throughout the region.

The completion of site preparation and grading, construction of necessary amenities and project design will allow the MFTA to move onto Phase 3 which is the actual construction of the Center.

The ultimate goal will be to own and operate the premier outdoor training and educational facility in the country. ## Activity 2: Site Preparation /Grading and Site Amenities

#### Activity Budget: \$800,000

Site preparation and grading include mobilization, staking, clearing/grubbing, roadway construction, culverts, vegetation replacement, erosion control and parking site leveling. Site amenities include primitive campsites, access road, parking, bog walk, archery range, training pond, fencing, gate and bleachers.
