Describe the opportunity or problem your proposal seeks to address. Include any relevant background information.

The City of Sartell has an incredible opportunity to transform a former industrial mill site into a thriving, mixed-use destination that embraces the natural environment, connecting people to the outdoors and Mississippi River while embracing the site's history, and enhancing the community's quality of life. A paper mill originally operated at the site from 1905 to 2012, when a catastrophic explosion and fire caused operations to cease. Most of the buildings were deconstructed and recycled, however the building slabs, footings, and concrete rubble remain and cover the entire site. Concrete, gravel, and rubble extend all the way up to the riverbank, providing zero natural habitat. The site has languished over the past decade, sitting vacant and unused. In 2023, the City purchased the property, to reinvigorate the mill site by creating public green spaces, connections to the Mississippi River, a riverwalk corridor to embrace the Mississippi River and nature environment and foster economic redevelopment.

The project will help restore native habitat along the Mississippi River, construct a multiuse riverwalk trail, add a dock system connecting the public to the Mississippi River and extend utilities to serve the property and future park amenities. This project will connect people to the outdoors where they will be able to participate in fishing, kayaking, canoeing, boating, and walking/biking all within public spaces along the river. Because of the scale of the project, we are requesting funding to complete four critical elements within the riverwalk. First, the project will restore habitat along the Mississippi River by removing the existing concrete, gravel and rubble and creating green space that includes native plants and trees, creating habitats for pollinators and wildlife. Second, the project will include a multiuse riverwalk trail along the green corridor. The project will create nearly half a mile of newly paved, ADA-compliant pathways, designed for pedestrians, bicyclists, and inline skaters. Third, a dock system will be constructed to directly connect residents to the Mississippi River and provide boat access to the site. Utilities will be extended along the corridor to provide water and sewer service for the mill site and future park amenities.

What are the specific project outcomes as they relate to the public purpose of protection, conservation, preservation, and enhancement of the state's natural resources?

This project will protect and enhance the Mississippi River and the nearby land by removing impervious surface at the site and restoring native vegetation. The transformation of the site from its past industrial use to green space will foster the return of wildlife, create a natural filter between the site and the Mississippi River, stabilize the Mississippi Riverbank, and enhance the natural beauty of the river and surrounding area. The riverwalk trail and dock system expands the trails and natural areas connecting green spaces, improves accessibility and safety, and encourages the public to recreate and engage with nature.

Activities and Milestones

Activity 1: Design

Activity Budget: \$52,700

Activity Description:

The trail and utility extension design are already 90% completed. Design will include a removal plan to facilitate the removal of the existing concrete and remaining industrial debris up to 3-feet deep along a 3000 foot long, 50-foot-wide corridor adjacent to the Mississippi River. The void left from the removals will be replaced with fill and topsoil to create an environment to sustain vegetation into the future. A vegetation planting plan and long-term maintenance plan for the 50-foot-wide corridor will be developed creating a natural riparian habitat and ensuring success of the plantings into the future. The design will also include the removal of a small section of wood fencing located within the river that was formally used to contain logs. This will allow for boat traffic to access the dock system which will be designed to meet ADA standards. Final plan and profiles will be designed for the trail system and the utility extension. In addition to the construction plans, project specifications will be completed to solicit bids for the work to be completed. This phase will also include obtaining necessary permits and a Phase 2 Archeological survey and consultation with.

Activity 2: Construction

Activity Budget: \$1,379,600

Activity Description:

A contractor will be obtained through a competitive bid process to complete the habitat restoration and construction of the trail, dock system, and utilities. The contractor will remove the existing concrete, gravel and footings from the 50-foot wide, 3000-foot corridor. The Phase 1 and Phase 2 Environmental Assessment did not find evidence of contamination with the 3000 linear foot, 50-foot wide corridor. The project does not include contamination or environmental clean-up. The contractor will then install the water and sewer utilities, followed by filling the voids created by the removals with borrow material, compost and topsoil. This will create an environment filled with nutrients to support vegetation establishment and growth. The contractor will then construct the trail, dock system and install grasses, trees and shrubs based on the designed planting plan to restore native vegetation and create habitat along the Mississippi River. The Sartell Public Works and Parks departments will utilize the record drawings, maintenance manuals, and the vegetation and planning management plan developed during the design phase to provide ongoing care for the habitat and project elements to ensure ongoing and continued success.

The City will oversee implementation of the project and will select a contractor through a competitive bid process. The city has completed a feasibility plan for the docks and restoration projects, the proposed trail system and utility extension have been designed and are ready for immediate bidding and construction. The City established a special fund to help pay for these projects and has already invested a significant amount of money, more than \$500,000 to-date, for improvements related to the mill property. The city is committed to the project but needs grant assistance to fully complete the project components.

Restoration

The City of Sartell currently owns the property, which encompasses the proposed project area. The City will retain the property, creating a park along the Mississippi River and retaining ownership and maintenance responsibilities into the future.

2. Summarize the components and expected outcomes of restoration and management plans for the parcels to be restored by your organization, how these plans are kept on file by your organization, and overall strategies for long-term plan implementation.

The restoration project will provide guidance on multiple components to facilitate removing existing concrete, gravel and footing remnants along the Mississippi River, adding topsoil, reintroducing native vegetation, construction of a multi-use trail, river access, and dock system and utility extension. The project does not include contamination or environmental clean-up. Expected outcomes include the revitalization of the riparian area through the establishment of native vegetation, helping to provide additional habitat for pollinators and wildlife. The design phase of the project will include the development of a vegetation and planting maintenance plan, multi-use trail, dock system with river access and extension of water and sewer utilities. The record drawings and maintenance plan will educate and identify strategies for the Sartell public works and parks department. This will ensure the long-term success of the project and riparian habitat area created. The maintenance plan will be kept and filed with the Parks Department and the activities and strategies will be included within the city's annual budget.

3. Describe how restoration efforts will utilize and follow the Board of Soil and Water Resources "Native Vegetation Establishment and Enhancement Guidelines" in order to ensure ecological integrity and pollinator enhancement.

The Board of Soil and Water Resources "Native Vegetation Establishment and Enhancement Guidelines" will be used to aid in the development of plans and specifications for the proposed project. The City of Sartell utilizes SEH Inc. as their city engineer. SEH has extensive experience in designing habitat restoration projects meeting the BWSR guidelines. SEH will lead and review the proposed planting plans to ensure that they meet they ecological integrity and pollinator enhancement based on the BSWR guidelines. The city will also meet with the local SWCD to help review and provide input on the vegetation and planning plans.

4. Describe how the long-term maintenance and management needs of the parcel being restored with these funds will be met and financed into the future.

The City of Sartell has a dedicated Park Fund to finance park maintenance and management activities. The project area will become part of the City's Park system. The long-term maintenance and management of the park and habitat area will be financed through the park Fund and the city's annual budget.

5. Describe how consideration will be given to contracting with Conservation Corps of Minnesota for any restoration activities.

As the project is designed and prepared for bidding, consideration will be given to project splits and possibilities for the City to contract with Conservation Corps of Minnesota to complete certain/native plantings.
